GOLDEN BEACH, FLORIDA RESOLUTION NO. 1217.00

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, AUTHORIZING THE TOWN MANAGER TO HAVE THE CENTER ISLAND SEAWALL REPAIRED, ON AN EMERGENCY BASIS, AFTER COUNSEL'S REVIEW OF QUOTES. THE MANAGER IS NOT TO EXCEED THE SUM OF \$35,000 WHICH IS TO INCLUDE A RAILING AND SPECIFICATION DRAWING AND SCOPE OF WORK

WHEREAS, the Town of Golden Beach maintains a seawall on Center Island; and

WHEREAS, the seawall was badly damaged by Hurricane Irene and is near collapse; and

WHEREAS, the condition of the seawall poses a serious and great threat to the health and welfare of the residents of Golden Beach; and

WHEREAS, Section 2-275, Subsection 1, of the Code of Ordinances of the Town of Golden Beach, provides for the acquisition of goods and services, in an emergency situation, can be accomplished without the Town's bid procedures.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE TOWN OF GOLDEN BEACH AS FOLLOWS:

- Section 1. That the Town Manager is hereby authorized to obtain quotes to have repairs to the Center Island seawall done immediately and completed on an expedited basis.
- Section 2. That the Town Manager is authorized to have the repairs effected, after the Town Counsel's review of the quotes as obtained by the Town Manager. The Town Manager is not to exceed the sum of \$35,000 which is to include a railing, specification drawing and scope of work.
- Section 3. Conflict. That all Resolutions or parts of Resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
- Section 4. Severability. Should any provision of this Resolution be declared by a Court of competent jurisdiction to be invalid, the same shall not affect the validity of this Resolution as a whole, or any part thereof, other than the part declared to be invalid.
- Section 5. Effective date. That this Resolution shall be become effective upon approval of the Town Council.

The Motion to adopt the foregoing Resolution on first reading was offered by Mayor Addicott, seconded by Vice Mayor Paruas, and on roll call the following vote ensued:
