

GOLDEN BEACH, FLORIDA

RESOLUTION NO. 1220.00

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, APPOINTING COUNCILMAN STANLEY J. FEINMAN, DMD, AS THE VICE MAYOR, AS PROVIDED IN THE TOWN CHARTER; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Town Charter Section 3.04 provides "the Council shall: Be the exclusive judge of the qualifications of the Mayor and Councilmembers...;" and

WHEREAS, a regular Councilmember term is four years, staggered, with two Councilmembers and the Mayor being elected every odd year; and

WHEREAS, pursuant to Town Charter Section 6.06 provides, "For a period of one year the candidate for office of Council receiving the highest number of votes cast at the general election shall serve as Vice Mayor... Thereafter, the candidate receiving the second highest number of votes cast shall serve as Vice Mayor for one year...;" and

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the above stated preambles are true and correct and adopted by the Town Council as part of this resolution.

Section 2. That Al Paruas, CPE, has served as Vice-Mayor from February 16th, 1999 until February 15th, 2000. Pursuant to the Town of Golden Beach Charter, Section 6.06, Stanley J. Feinman DMD, the recipient of the second highest number of votes cast at the general election, shall serve as Vice-Mayor for a term commencing February 16, 2000 and ending February 21, 2001.

Section 3. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.


Section 4. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 5. Effective Date. That this Resolution shall become effective on February 16th, 2000, upon approval of the Town Council.

The Motion to adopt the foregoing Resolution was offered by Mayor Addicott, seconded by Councilman Einstein and on roll call the following vote ensued:




