## GOLDEN BEACH, FLORIDA RESOLUTION NO. 1264.00

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE TOWN MANAGER TO CONTINUE THE DUTIES OF TOWN MANAGER BEYOND THE EFFECTIVE RESIGNATION DATE OF OCTOBER 1,2000; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Manager tendered her resignation on June 20, 2000 effective October 1, 2000; and.

WHEREAS, the Town Council accepted said resignation; and,

WHEREAS, the Town Council has not appointed a new Town Manager to fulfill the duties, responsibilities and obligations of the position of Town Manager; and,

WHEREAS, the Town Manager indicated her willingness to continue in said capacity until the Town Council appoints a permanent Town Manager,

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Manager, Rosemary Wascura, shall continue to discharge the duties, responsibilities and obligations of the position of Town Manager in an interim capacity on a month to month basis beginning October 1, 2000 provided that either Ms. Wascura or the Town Council may terminate the month to month at will employment upon fifteen (15) days notice to the other.

Section 2. That the terms and conditions of employment shall afford Rosemary Wascura no greater salary, benefits or other form of compensation other than what she is presently receiving and

that the continuation of her employment beyond her resignation date of October 1, 2000 affords her no greater property right or entitlement to her employment other than that which she currently enjoys. Further, said employment is extended solely for the convenience and benefit of both parties until an individual to serve as Town Manager is selected by the Town Council.

Section 3. Severability. That the provisions of this resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

<u>Section 3. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 4.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
