

**GOLDEN BEACH, FLORIDA  
RESOLUTION NO. 1279.00**

A RESOLUTION OF THE TOWN COUNCIL OF THE  
TOWN OF GOLDEN BEACH FLORIDA, FLORIDA,  
APPROVING THE CONTRACT WITH ESSENTIAL NET  
SOLUTIONS (ENS) AS LOW BIDDER ON A 600 Mhz  
SERVER; TWO PENTIUM III 550 Mhz WORKSTATIONS;  
INSTALLATION AND SOFTWARE FOR A TOTAL COST  
OF \$8,619.59; SAID FUNDS TO BE EXPENDED FROM 524-  
6400-01 BUILDING & ZONING/MACHINERY &  
EQUIPMENT; PROVIDING FOR SEVERABILITY;  
PROVIDING FOR CONFLICTS; AND PROVIDING AN  
EFFECTIVE DATE.

WHEREAS, the Town Administration desires to replace the existing computer server and two work stations at Town Hall; and

WHEREAS, the Town Administration has received bids from three (3) qualified companies who perform such services and Essential Net Solutions, (ENS), is the lowest qualified bidder.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AS FOLLOWS:

**Section 1.** That funds for this expenditure, are to be appropriated from the building & zoning/ machinery & equipment account (#524-6400-01).

**Section 1. Severability.** Should any provisions of this Resolution be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the Resolution as a whole, or any part thereof, other than the part declared to be invalid.


**Section 2. Conflict.** That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

**Section 3. Effective Date.** That this Resolution shall become effective upon approval of the Town Council.
