A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; PROVIDING FOR SALE/DISPOSAL OF SURPLUS PROPERTY PURSUANT TO TOWN CODE SECTION 2-308 OF THE TOWN OF GOLDEN BEACH; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 2-308 of the Town Code provides for the Sale/Disposal of surplus property; and

- Section 2. That the Town Manager is hereby authorized to dispose of the surplus property listed on the attached Exhibit "A" in conformity with the provisions of Section 2-308 of the Town Code.
- **Section 3**. Conflict. That all resolutions or parts of resolutions in conflict with this resolution are hereby repealed to the extent of the conflict.
- <u>Section 4</u>. Severability. Should any provisions of this Resolution be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the Resolution as a whole, or any part thereof, other than the part declared to be invalid.
- <u>Section 5</u>. Effective date. That this Resolution shall become effective upon approval of the Town Council.
