RESOLUTION NO.1293.01

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE TOWN MANAGER TO HAVE THE A1A SPRINKLER SYSTEM REPAIRED AND A PORTION REPLACED, ON AN EMERGENCY BASIS, AFTER COUNSEL'S REVIEW OF QUOTES. THE MANAGER IS NOT TO EXCEED THE SUM OF \$20,000.00; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING AN EFFECTIVE DATE THEREFOR.

WHEREAS, the Town of Golden beach maintains the median on AlA; and

WHEREAS, the sprinkler system on A1A was badly damaged by tree removal and traffic; and

WHEREAS, the condition of the sprinkler system poses a threat to the health and welfare of the plantings on AIA and some portions do not suit our needs and should be converted to a "pop-up" system; and

WHEREAS, Section 2-275, Subsection 1, of the Code of Ordinances of the Town of Golden Beach, provides for the acquisition of goods and services, in an emergency situation, can be accomplished without the Town's bid procedures.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

- <u>Section 1.</u> That the Town Manager is hereby authorized to obtain quotes to have repairs to the AlA sprinkler system and a portion of the existing system converted to better suit the needs of the Town done immediately and completed on an expedited basis.
- Section 2. That the Town Manager is authorized to have the repairs effected, after the town Council's review of the quotes as obtained by the Town Manager. The town Manager is not to exceed the sum of \$20,000.00 and is to receive written approval of the type of irrigation system by the landscape architect.
- Section 3. Severability. That the provisions of this Resolution are declared to be severable and if any section,

sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

<u>Section 4. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 4. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
