

**TOWN OF GOLDEN BEACH
RESOLUTION NO. 1299.01**

**A RESOLUTION OF THE TOWN COUNCIL
OF THE TOWN OF GOLDEN BEACH,
FLORIDA; CERTIFYING THE RESULTS OF
THE FEBRUARY 20, 2001, TOWN ELECTION
FOR MAYOR AND TWO TOWN
COUNCILMEMBERS; DESIGNATING THE
VICE MAYOR; PROVIDING FOR
SEVERABILITY; PROVIDING FOR
CONFLICTS AND PROVIDING AN
EFFECTIVE DATE.**

WHEREAS, pursuant to law and properly noticed, a municipal election was held on February 20, 2001, in the Town of Golden Beach; and

WHEREAS, The Town Council desires to accept the certification of the results of the election and designate a Vice Mayor pursuant to the Town Charter;

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, THAT:

Section 1. That the Certification of the results of the February 20, 2001, Town election is accepted as follows:

A. Mayor:	Michael Addicott	<u>261</u>
	Sara Chikovsky	<u>98</u>
B. Town Council: 4 year term	Bernard Einstein	unopposed
C. Town Council 4 year term	Glenn Singer	unopposed

*winning candidate

Section 2. A. That based upon the results, Michael L. Addicott is declared Mayor for a two-year term commencing immediately.

B. That based upon the results, Bernard Einstein is declared Town Councilmember for a four year term, as an unopposed candidate, commencing immediately.

- C. That based upon the results, Glenn Singer, is declared Town Councilmember for a four-year term, as an unopposed candidate, commencing immediately.

Section 3. That Glenn Singer is hereby designated Vice Mayor for a one-year term commencing immediately, to be followed by Bernard Einstein, Vice Mayor for the succeeding one-year term as decided by the Town Council as both candidates were unopposed.

The Motion to adopt the foregoing Resolution was offered by Vice-Mayor Feinman, seconded by Councilman Paruas, and on roll call the following vote ensued:
