RESOLUTION NO. 1310.01

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AMENDING RESOLUTION NO. 1283.00; CONFIRMING THE SELECTION BY THE MAYOR OF ADDITIONAL AD HOC PEDESTRIAN SAFETY COMMITTEE MEMBERS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, there is concern in the Town for the safety of pedestrians on the town streets and the Mayor would like to appoint members to an ad hoc pedestrian safety committee to address the issue of the safety and well-being of the residents of the Town; and

WHEREAS, Sec. 3.04 of the Town Charter provides for the appointment of such board members by the Mayor subject to the confirmation of the Town Council; and

WHEREAS, Resolution No. 1283.00 appointed three members to said Board; and

WHEREAS, the Mayor has selected the additional residents of the Town to serve on the ad hoc pedestrian safety committee and has charged the committee members to report back to the Town Council within three months with suggestions to make Golden Beach a pedestrian friendly Town;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That Resolution No. 1283.00 be and the same is hereby amended as follows: That the following residents of the Town of Golden Beach be and are hereby appointed to serve on the Ad Hoc Pedestrian Safety Committee and his/her appointment by the Mayor is hereby confirmed by the Town Council to serve at the pleasure of the Town Council until December, 2002, and thereafter to run concurrently with the term of office of the Mayor, at which time the term shall automatically terminate, unless reappointed.

Section 4. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
