## RESOLUTION NO. 1319.01

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE EXPENDITURE OF \$80,000.00 FOR CONSTRUCTION OF A POLICE GUARDHOUSE FROM THE FUNDS ACQUIRED UNDER THE CONTRABAND FORFEITURE ACT AS PROVIDED IN CHAPTER 932, FLORIDA STATUTES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING AN EFFECTIVE DATE THEREFOR.

WHEREAS, the Town has acquired funds under the Contraband Forfeiture Act as contained in Chapter 932, Florida Statutes; and

WHEREAS, the Police Department has recommended expenditure of the sum of \$80,000.00 for the construction of a police guardhouse; and

WHEREAS, the expenditure of such funds assists in crime prevention and other law enforcement purposes as deemed appropriate by the Town Council;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

- <u>Section 1.</u> The expenditure of the sum of \$80,000.00 from the Contraband Forfeiture funds for the construction of a police guardhouse be, and the same is hereby approved.
- Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
- <u>Section 3. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 4. Effective Date.</u> That this Resolution shall become effective immediately upon approval of the Town Council.
