A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA SUPPORTING TEVE 41, WJAM-41, IN THEIR REQUEST TO THE FEDERAL COMMUNICATIONS COMMISSION (FCC) TO ENABLE THEM TO PROVIDE HIGHER QUALITY SIGNS TO THE LOCAL HISPANIC COMMUNITY AS WELL AS SUPPORTING THEIR FUTURE REQUEST FOR A "MUST CARRY" STATUS; PROVIDING FOR THE TOWN CLERK TO SEND LETTERS OF SUPPORT FROM THE MAYOR AND TOWN COUNCIL TO COMMISSIONERS OF THE FEDERAL COMMUNICATIONS COMMISSION ON BEHALF OF THE CONSTITUENTS OF GOLDEN BEACH, THE MAYOR AND COUNCIL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

- Section 1. That the Town Council hereby supports TeVe 41, WJAM-41 in their request to the Federal Communications Commission (FCC) to enable them to provide higher quality signs to the local hispanic community as well as supporting their future request for a "must carry" status; and providing for the Town Clerk to send letters of support from the Mayor and Town Council to the Commissioners of the Federal Communications Commission on behalf of the constituents of Golden Beach, the Mayor and Council.
- Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
- <u>Section 3.</u> Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
- <u>Section 4. Effective Date.</u> That this Resolution shall become effective immediately upon approval of the Town Council.
