A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE TOWN MANAGER TO ADVERTISE FOR BIDS FOR LANDSCAPING AND IRRIGATION FOR A1A; PROVIDING FOR BID OPENING AND REVIEW AND SELECTION BY THE TOWN COUNCIL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town desires to landscape the area along A1A and to provide for bid opening, review and selection by the Town Council;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

- Section 1. That the Interim Town Manager be, and she is hereby authorized to advertise for bids for landscaping and irrigation for A1A and provide for bid opening and review and selection by the Town Council.
- Section 2. The bidding procedure shall be in accordance with all relevant ordinances, statutes, and charter provisions. The Council reserves the right to determine the lowest and most responsive bidder and the right to reject all bids.
- Section 3. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
- Section 4. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
