## **RESOLUTION NO. <u>1395.02</u>**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE TOWN MANAGER TO ADD THREE FULL TIME COMMUNITY SERVICE OFFICERS TO THE POLICE DEPARTMENT AND ADDING LINE ITEM 521-1360-01 TO ACCOMMODATE SUCH EXPENDITURE; TRANSFERRING \$24,960.00 FROM LINE ITEM 521-1200-01 POLICE SERGEANTS AND \$31,200.00 FROM LINE ITEM 521-1300-01 POLICE PATROLMEN FOR PROPOSED SALARIES AND BENEFITS UNTIL THE END OF THE 2001-2002 FISCAL YEAR; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

## NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Council hereby authorizes the Town Manager to add three full time community service officers to the Police Department and adding line item 521-1360-01 to accommodate such expenditure; transferring \$24,960.00 from line item 521-1200-01 police sergeants and \$31,200.00 from line item 521-1300-01 police patrolmen for proposed salaries and benefits until the end of the 2001-2002 fiscal year.

<u>Section 2.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 4. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
