**RESOLUTION NO. 1398.02**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE MAYOR TO APPOINT A SEARCH COMMITTEE FOR THE VACANT POSITION OF POLICE CHIEF; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** That the Mayor be, and he is hereby authorized to form a search committee for the vacant position of Police Chief.

**Section 2.** The Council hereby ratifies the appointment of Tony Pirrone, Councilmember Glenn Singer and Dr. Jose Iglesias to serve on the search committee.

**Section 3.** The advertisement will be in accordance with the attached exhibit.

**Section 4. Severability.** That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

**Section 5. Conflict.** That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

**Section 6. Effective Date.** That this Resolution shall become effective immediately upon approval of the Town Council.



The Motion to adopt the foregoing resolution was offered by Mayor Addicott, seconded by Councilmember Singer and on roll call the following vote ensued:


