A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; GRANTING VARIANCE REQUEST FOR THE PROPERTY LOCATED AT 277 OCEAN BOULEVARD, GOLDEN BEACH, FLORIDA, GB SECTION "C", LOT 39 AND S. ½ OF 40, BLOCK A; REQUESTING RELIEF FROM TOWN CODE SECTION 66-136 TO ALLOW A SIX FOOT SETBACK AT SOUTH SIDE IN LIEU OF TEN FEET REQUIRED BY CODE; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Jonas and Judith Mimoun have applied for the following variance:

(1) A variance requesting relief from Town Code Section 66-136 to allow a six foot setback at south side in lieu of ten feet required by code.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the requested variance is hereby approved as follows: relief from Town Code Section 66-136 to allow a six foot setback at south side in lieu of ten feet.

Section 2. That the application as approved, is subject to the following conditions:

- (a) A Building Permit for the contemplated work pursuant to the Variance must be obtained within two (2) years from the date of this Resolution. If no Building Permit is issued within the two (2) year time limit, then the Variance approval will be null and void.
- (b) The applicant shall record a certified copy of this Resolution in the public records of Miami-Dade County.

Section 3. The Building and Zoning Director is hereby directed to make the necessary notations upon the maps and records of the Town of Golden Beach Building and Zoning Department and to issue all permits in accordance with the terms and conditions of this Resolution. A copy of this Resolution shall be attached to the building permit application documents.

<u>Section 4.</u> Conflict. That all Resolutions or parts of Resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 5.</u> Severability. Should any provisions of this Resolution be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the Resolution as a whole, or any part thereof, other than the part declared to be invalid.

<u>Section 6.</u> Effective <u>Date.</u> That this Resolution shall become effective immediately upon approval of the Town Council.
