RESOLUTION NO. 1402.02

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA SUPPORTING THE EFFORTS OF THE SOUTH FLORIDA ORCHID SOCIETY AND THE FORT LAUDERDALE ORCHID SOCIETY TO HOST A WORLD ORCHID CONFERENCE IN THE CITY OF PINECREST IN 2008; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the United States last hosted a World Orchid Conference in 1984; and

WHEREAS, the South Florida Orchid Society and the Fort Lauderdale Orchid Society are joining together to present a bid to host the 19th World Orchid Conference in Pinecrest in 2008; and

WHEREAS, tens of thousands of people will attend the event and thereby boost the local economy;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Council of the Town of Golden Beach supports the efforts of the South Florida Orchid Society and the Fort Lauderdale Orchid Society to host the 19th World Orchid Conference in Pinecrest in 2008.

<u>Section 2.</u> The Clerk be, and she is hereby directed to forward a copy of this Resolution to the World Orchid Conference Trustees and Site Selection Committee.

Section 3. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

<u>Section 3. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 4. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
