## **RESOLUTION NO. 1406.02**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA SUPPORTING THE RECOMMENDATION OF THE SECURITY COMMITTEE TO HIRE PRIVATE SECURITY FOR THE GUARDHOUSE AND AUTHORIZING THE TOWN MANAGER TO SEEK PROPOSALS FOR THIS SERVICE FOR THE TOWN; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Security Committee has recommended that the Town hire private security for the guardhouse;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

- <u>Section 1.</u> That the Town supports exploring the recommendation of the Security Committee to hire private security for the guardhouse and hereby authorizes the Town Manager to seek written proposals for this service for the Town and report back to the Town Council.
- <u>Section 2.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
- <u>Section 3. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
- <u>Section 4.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
