RESOLUTION NO. 1420.02

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA URGING THE FLORIDA DEPARTMENT OF TRANSPORTATION TO ADD A PEDESTRIAN SAFETY ZONE TO ANY PLANNED RENOVATION OF THE LEHMAN CAUSEWAY; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Lehman Causeway bridge, as currently configured, is dangerous for pedestrians and bicyclists to cross; and

WHEREAS, residents of Golden Beach and Sunny isles Beach who cross to Aventura have to walk on the shoulder of the roadway without any barrier between rapidly moving vehicular traffic and themselves; and

WHEREAS, plans are being made to overhaul the bridge;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Florida Department of Transportation is urged to add a pedestrian safety zone to any planned renovation of the Lehman Causeway.

<u>Section 2.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
