**RESOLUTION NO. 1454.04**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA DESIGNATING SIGNATORIES FOR THE ACCOUNTS AT NORTHERN TRUST BANK AND THE FLORIDA DEPARTMENT OF ADMINISTRATION; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Town currently has accounts at Northern Trust Bank and with the Florida Department of Administration and signatories need to be designated for those accounts.

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** That the authorized signatories on the Northern Trust Bank account and with the Florida Department of Administration shall be two of the following: Mayor, Vice Mayor, (Interim) Town Manager and/or Building Official.

**Section 2. Severability.** That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

**Section 3. Conflict.** That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

**Section 4. Effective Date.** That this Resolution shall become effective immediately upon approval of the Town Council.



The Motion to adopt the foregoing resolution was offered by Mayor Addicott seconded by Councilmember Singer and on roll call the following vote ensued:


