Section 1. That LISA K. ARONSON be, and she is hereby appointed as Interim Town Manager for the term of May 1, 2003 to July 31, 2003 consistent with the terms and conditions as contained in the Letter Agreement, a copy of which is attached hereto as Exhibit "A" and incorporated herein as if set forth in full.

<u>Section 2. Severability.</u> That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 4.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.

Dear Ms. Aronson:

This will confirm the terms and conditions of your position as Interim Town Manager for the period of May 1, 2003 through and including July 31, 2003.

You will be compensated on a periodic basis based upon an annual fee of \$80,000, serving in the capacity as an independent contractor. In addition to the above compensation you will receive the following Until Carlier of fermination on. July 31, 2003:

- Vehicle allowance of \$400.00 per month.
- Cellular phone allowance of \$100.00 per month.
- Reimbursement for expenses ordinarily incurred in the discharge of your responsibilities at the same rate as provided for other Town employees.
- Each party will provide two (2) weeks notice to the other should either choose to terminate this Agreement provided, however, that the term of this Agreement ends on July 31, 2003 without any notice requirement required to be given by the Town absent further agreement.
- Two weeks of absence may be taken during the month of July provided all pending matters are under control. Further, it is understood that there is no paid vacation as part of this Agreement and any time used is without compensation.
 - Legal protections normally afforded Town Managers for the Town will be afforded to you. Reimbursement for professional association dues for ICMA and American Society for Public Administration will be provided up to \$200.00. The Town agrees to renew annual membership to the Miami-Dade County Management Association for the (Interim) Town Manager.

The monthly cash equivalent of all insurances normally provided to Town employees which include health insurance, life insurance, dental insurance and short and long term disability insurance.
