**RESOLUTION NO. 1481.03**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA RATIFYING AND CONFIRMING THE RECOMMENDATION OF THE MAYOR AND THE SELECTION COMMITTEE OF GREGORY FELDMAN AS POLICE CHIEF OF THE TOWN OF GOLDEN BEACH; AUTHORIZING THE MAYOR AND TOWN MANAGER TO ENTER INTO AN EMPLOYMENT AGREEMENT; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** That the Town Council ratifies and confirms the recommendation of the Mayor and the Selection Committee of Gregory Feldman as Police Chief of the Town of Golden Beach, subject to finalization of contract negotiations with an effective start date of June 30, 2003.

**Section 2.** The Mayor and Town Manager be, and they are hereby authorized to enter into an Employment Agreement with Gregory Feldman.

**Section 3. Severability.** That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

**Section 4. Conflict.** That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.


**Section 5. Effective Date.** That this Resolution shall become effective immediately upon approval of the Town Council.

The Motion to adopt the foregoing resolution was offered by Vice Mayor Iglesias seconded by Councilmember Singer and on roll call the following vote ensued:


