RESOLUTION NO. 1484.03

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE PAYMENT TO MIAMI-DADE WATER AND SEWER DEPARTMENT IN THE AMOUNT OF \$9,778.05 FOR REPAIRING AND RESTORING SERVICE TO A SEWER LATERAL AT 167 GOLDEN BEACH DRIVE DUE TO SEWER LINE AT WRONG ELEVATION (SLOPE), WHICH SUM INCLUDES THE RESTORATION OF DRIVEWAY PAVERS AND ROADWAY; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Council hereby authorizes the payment to Miami-Dade Water and Sewer Department in the amount of \$9,778.05 for services rendered in 2001 and invoiced on January 31, 2003 for repairing and restoring service to a sewer lateral at 167 Golden Beach Drive due to a sewer line at a wrong elevation (slope) causing sewer back-ups at residence; which sum also includes the restoration of driveway pavers and roadway.

Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 4. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.




