## **RESOLUTION NO. <u>1491.03</u>**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA APPOINTING JIM STOKES AS SPECIAL MASTER TO HEAR CODE ENFORCEMENT MATTERS FOR THE TOWN OF GOLDEN BEACH; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

## NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That JIM STOKES be, and he is hereby appointed as Special Master to hear code enforcement matters for the Town of Golden Beach. The term of appointment shall be for a one (1) year period unless earlier terminated by the Town Council. Compensation is at the rate of \$100.00 per hour with portions thereof to be prorated. Travel to and from hearing location is not compensated.

<u>Section 2.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

<u>Section 3. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 4.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
