A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA ADDING DARIO GONZALEZ, BUILDING OFFICIAL, AS AN ADDITIONAL SIGNATORY ON THE ACCOUNTS AT NORTHERN TRUST BANK AND THE FLORIDA DEPARTMENT OF ADMINISTRATION; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town currently has accounts at Northern Trust Bank and with the Florida Department of Administration and signatories need to be designated for those accounts.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

- <u>Section 1.</u> That Dario Gonzalez, Building Official, is hereby added as an additional signatory to sign Town checks on the Northern Trust Bank account and with the Florida Department of Administration along with the Mayor, Vice Mayor, (Interim) Town Manager and/or Town Clerk. Two signatures are needed to sign checks.
- Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
- <u>Section 3. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
- <u>Section 4.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
