**RESOLUTION NO. 1497.03**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE PURCHASE OF SIX M/A-COM PORTABLE HAND HELD RADIOS FOR THE POLICE DEPARTMENT FROM THE LAW ENFORCEMENT TRUST FUND; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING AN EFFECTIVE DATE THEREFOR.

**WHEREAS**, some of the existing inventory of hand held police radios can no longer be repaired and are being phased out by the provider; and,

**WHEREAS**, a newer model being offered is an improved and enhanced unit that meets the specifications that Miami-Dade Police Communications will be requiring all police departments to have in order to be compatible with their system; and,

**WHEREAS**, the Town desires to purchase six M/A-COM portable hand held radios for the Police Department from the Law Enforcement Trust Fund.

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** The purchase of six police radios from the Law Enforcement Trust Fund be, and the same is hereby approved.

**Section 2. Severability.** That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

**Section 3. Conflict.** That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.


**Section 4. Effective Date.** That this Resolution shall become effective immediately upon approval of the Town Council.
