**RESOLUTION NO. 1504.03**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA REPEALING RESOLUTION 1481.03 AUTHORIZING THE MAYOR AND TOWN MANAGER TO ENTER INTO AN EMPLOYMENT AGREEMENT WITH GREGORY FELDMAN AS POLICE CHIEF; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Town previously authorized the Mayor and town Manager to enter into an Employment Agreement with Gregory Feldman; and,

**WHEREAS**, Gregory Feldman has withdrawn his name for consideration as the police chief for the Town of Golden Beach;

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** That Resolution 1481.03, approved on May 20, 2003, is hereby repealed in its entirety.

**Section 2. Severability.** That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

**Section 3. Conflict.** That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.


**Section 4. Effective Date.** That this Resolution shall become effective immediately upon approval of the Town Council.

The Motion to adopt the foregoing resolution was offered by Mayor Addicott, seconded by Vice Mayor Iglesias and on roll call the following vote ensued:


