RESOLUTION NO. 1508.03

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA TO APPOINT MAYOR MICHAEL ADDICOTT AS THE VOTING DELEGATE FOR THE TOWN OF GOLDEN BEACH AT THE FLORIDA LEAGUE OF CITIES 77TH ANNUAL CONFERENCE TO BE HELD IN LAKE BUENA VISTA, FLORIDA, AUGUST 14, 2003 THROUGH AUGUST 16, 2003; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida League of Cities is the official organization of the cities, towns and villages of the State of Florida; and

WHEREAS, the Florida League of Cities was designed and established to meet and serve the needs of Florida's municipal officials; and

WHEREAS, the officials of Florida's municipal governments realize they can solve their common problems only by a united effort.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. Mayor Michael Addicott is appointed as the voting delegate representing the Town of Golden Beach, Miami-Dade County, Florida, at the Florida League of Cities 77th Annual Conference to be held in Lake Buena Vista, Florida, August 14, 2003 through August 16, 2003.

Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.


Section 4. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.


