RESOLUTION NO. 1513.03

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE TOWN MANAGER TO TRANSFER AN ADDITIONAL THIRTY THOUSAND DOLLARS (\$30,000.00) FROM THE GENERAL FUND, ACCOUNT NUMBER 596-389000 TO THE STORMWATER UTILITY FUND FOR STORMWATER CONSTRUCTION, ACCOUNT NO. 410-500634 IN THE AMOUNT OF THIRTY THOUSAND DOLLARS (\$30,000.00) FOR THE INSTALLATION OF A FORCE MAIN PIPE AND RELATED MATERIALS AS PART OF A MASTER STORMWATER DRAINAGE SYSTEM; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Golden Beach adopted a General Fund Budget for the Fiscal Year 2002-2003; and

WHEREAS, the Town Council has adopted a resolution authorizing the emergency purchase of a force main pipe and related materials; and

WHEREAS, the Town Manager has recommended that an interdepartmental transfer be made from the General Fund to the Stormwater Utility Fund for stormwater construction to install a force main pipe and related materials as part of a master stormwater drainage system;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Manager is hereby authorized to transfer up to Thirty Thousand Dollars (\$30,000.00) from Account No. 596-389000, General Fund into Account No. 410-500634, Stormwater Utility Fund for stormwater construction.

Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.


Section 4. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.


