RESOLUTION NO. 1514.03

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA SETTING THE PROPOSED MILLAGE RATE AND ACCEPTING THE ROLL-BACK RATE PURSUANT TO SECTION 200.065(2)(b), FLORIDA STATUTES, AND SETTING THE DATE, TIME AND PLACE AT WHICH PUBLIC HEARINGS WILL BE HELD TO CONSIDER THE TOWN OF GOLDEN BEACH PROPOSED MILLAGE RATE FOR THE 2003-2004 FISCAL YEAR AND THE TENTATIVE BUDGET; AND DIRECTING THAT A CERTIFIED COPY OF THIS RESOLUTION BE TRANSMITTED TO THE MIAMI-DADE COUNTY PROPERTY APPRAISER AND TAX COLLECTOR; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 200.065, Florida Statutes, commonly known as the "Truth in Millage Bill" or the "TRIM" Bill provides that a taxing authority shall advise the Property Appraiser of its proposed millage rate, of its current year rolled-back rate and of the date, time and place at which a public hearing will be held to consider the proposed millage rate and the tentative budget; and

WHEREAS, pursuant to Section 197.3632(7), Florida Statutes, the taxing authority must advise the Property Appraiser and Tax Collector of any non-ad valorem assessments that are to be collected pursuant to Section 197.3632 for the preparation of the Notice of Proposed Property Taxes ("TRIM Notice").

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. The proposed property tax millage rate of the Town of Golden Beach for fiscal year 2003/2004 shall not exceed 8.59 mills, which is equivalent to \$8.59 per \$1,000 of taxable assessed property valuation for the 2003/2004 fiscal year.

Section 2. The "rolled-back" millage rate for fiscal year 2003/2004, calculated pursuant to Section 200.065(1), Florida Statutes, is 7.3871 mills based on the certification of taxable value provided by the Property Appraiser's office.

Section 3. The date, time and place of the public hearing to consider the above proposed millage rate in Section 1 and 2 and the tentative budget shall be as follows:

Date: Tuesday, September 9, 2003
Time: 7:30 p.m.
Place: Town Hall
One Golden Beach Drive, Golden Beach, FL

Section 4. The date, time and place of the public hearing to consider adoption of the final millage rate and budget shall be as follows:

Date: Tuesday, September 16, 2003
Time: 7:30 p.m.
Place: Town Hall
One Golden Beach Drive, Golden Beach, FL

Section 5. The Town Clerk is hereby directed to send a certified copy of this resolution to the Property Appraiser and Tax Collector for Miami-Dade County.


Section 6. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
