A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE EXPENDITURE OF \$94,561.60 CONSISTENT WITH THE TERMS AND CONDITIONS OF THE "UTILITY WORK BY HIGHWAY CONTRACTOR (FDOT)" TO CONSTRUCT OR RECONSTRUCT A TRANSPORTATION FACILITY IDENTIFIED AS VERONA AVENUE BRIDGE FROM SOUTH ISLAND DRIVE TO GOLDEN BEACH DRIVE (FINANCIAL PROJECT 405904-1-56-01); PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

# NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. The Town Administration is hereby authorized to issue payment in the sum of \$94,561.60 consistent with the terms and conditions of the "Utility Work by Highway Contractor (FDOT)" to construct or reconstruct a transportation facility identified as Verona Avenue Bridge from South Island Drive to Golden Beach Drive (Financial Project 405904-1-56-01).

Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

<u>Section 3. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 4. Effective Date.</u> That this Resolution shall become effective immediately upon approval of the Town Council.
