A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING AND APPROVING THE INTERIM TOWN MANAGER TO PROCEED WITH THE ISSUANCE OF A REQUEST FOR PROPOSAL PURSUANT TO DIVISION 2. "PURCHASING PROCEDURE" OF THE CODE OF ORDINANCES FOR THE TOWN OF GOLDEN BEACH, FLORIDA PERTAINING TO TENNIS COURT RENOVATIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. The Interim Town Manager is hereby authorized to issue a Request for Proposal pertaining to tennis court renovations consistent with the requirements as set forth in the Code of Ordinances.

Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

<u>Section 3. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 4. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
