A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE TOWN MANAGER TO TRANSFER FROM THE GENERAL FUND, NUMBER 001, AS FOLLOWS: \$9,000 FROM COMMUNITY INVOLVEMENT, ACCOUNT NUMBER 511-500482; \$6,000 FROM LEGAL ADVERTISING, ACCOUNT NUMBER 511-500492; \$4,000 FROM PROFESSIONAL SERVICES, ACCOUNT NUMBER 513-500513; AND \$15,000 FROM MACHINERY & EQUIPMENT, ACCOUNT NUMBER 513-500640, FOR A TOTAL OF \$34,000 TO THE SPECIAL COUNCIL-LABOR ACCOUNT NUMBER 514-500312 TO PROVIDE PAYMENT FOR SPECIAL LEGAL SERVICES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Golden Beach adopted a General Fund Budget for the Fiscal Year 2002-2003;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Manager is hereby authorized to transfer from the General Fund Number 001 as follows: \$9,000 from Community Involvement, Account Number 511-500482; \$6,000 from Legal Advertising Account Number 511-500492; \$4,000 from Professional Services, Account Number 513-500513; and \$15,000 from Machinery & Equipment, Account Number 513-500640, for a total of \$34,000 to the Special Council-Labor Account Number 514-500312 to provide payment for special legal services.

Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 4. Effective Date.</u> That this Resolution shall become effective immediately upon approval of the Town Council.
