RESOLUTION NO. 1525.03

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA; ADOPTING THE TENTATIVE MILLAGE RATE OF THE TOWN OF GOLDEN BEACH FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2003 AND ENDING SEPTEMBER 30, 2004, PURSUANT TO SECTION 200.065, FLORIDA STATUTES (TRIM BILL); SETTING THE DATE, TIME AND PLACE FOR A PUBLIC HEARING TO ADOPT THE FINAL MILLAGE RATE FOR THE TOWN OF GOLDEN BEACH; AUTHORIZING THE TOWN CLERK TO ADVERTISE THE PUBLIC HEARING; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town has properly noticed the first public hearing scheduled for Tuesday, September 9, 2003 at 7:30 P.M. in the Council Chambers of the Town Hall located at One Golden Beach Drive, Golden Beach, Florida; and

WHEREAS, the said first public hearing was held as noticed and the public and all interested parties having had an opportunity to address their comments to the Town Council and having complied with the "TRIM" requirements of the Florida Statutes;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the tentative millage rate for the taxation of all real property lying within the boundaries of the Town of Golden Beach, Florida as presented by the Town Manager for the fiscal year commencing October 1, 2003 and ending September 30, 2004, be and is hereby fixed at the rate of 8.590 mills which is \$8.59 per one thousand dollars of assessed property value within the Town of Golden Beach.

Section 2. That the "rolled back rate" for the Town of Golden Beach is 7.3871 mills and that the tentative millage rate of 8.590 mills is 16.28% above the "rolled back rate."

- Section 3. That the second public hearing required by Section 200.065 of the Florida Statutes to adopt a final millage rate for the fiscal year commencing October 1, 2003 and ending September 30, 2004, be and is hereby set in the Town Council chambers, One Golden Beach Drive, Golden Beach, Florida at 7:30 P.M. on Tuesday, September 16, 2003.
- Section 4. That the Town Clerk is hereby authorized and directed to advertise the said public hearing as required by law.
- Section 5. That the Town Clerk is directed to forward certified copies of this Resolution to the Miami-Dade Property Appraiser, the Miami-Dade Revenue Collector and the Florida Department of Revenue.
- Section 6. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
- Section 7. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
- Section 8. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
