**RESOLUTION NO. 1547.03**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA RECEIVING AND ACCEPTING THE STORMWATER MANAGEMENT MASTER PLAN PREPARED BY WILLIAMS, HATFIELD & STONER, INC., DATED MARCH 1996; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Stormwater Management Master Plan is believed to have been previously provided to the Town of Golden Beach however, no paper trail can be found wherein the Town Council formally accepted said Master Plan; and,

**WHEREAS**, the Town Engineer, Craig A. Smith & Associates, Inc. requested formal documentation from the Town indicating the Town's receipt and acceptance of the Stormwater Management Master Plan; and;

**WHEREAS**, the Town of Golden Beach hereby acknowledges receipt and acceptance of the Stormwater Management Master Plan however, does not pass comment or make any opinion of any kind whatsoever as to the accuracy, relevance, or validity of the Stormwater Management Master Plan.

**NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.** That the Town Council hereby acknowledges receipt and acceptance of the Stormwater Management Master Plan dated March 1996 without endorsing or otherwise accepting as valid the contents contained therein.

**Section 2. Severability.** That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

**Section 3. Conflict.** That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

**Section 4. Effective Date.** That this Resolution shall become effective immediately upon approval of the Town Council.
