RESOLUTION NO. 1548.03

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING AN AGREEMENT BETWEEN THE TOWN OF GOLDEN BEACH AND BEST STRIPING, INC. FOR STRIPING OF ROADWAYS IN AN AMOUNT NOT TO EXCEED \$3,817.75 FROM ACCOUNT 541465; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Council hereby authorizes the expenditure of funds to Best Striping, Inc. in an amount not to exceed \$3,817.75 from Account No. 541465 for striping of the roadways consistent with Exhibit "A" attached hereto. The Mayor is hereby authorized to execute an Agreement with Best Striping, Inc. Such Agreement is subject to approval by the Town Attorney.

Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 4. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.






