## **RESOLUTION NO. <u>1549.03</u>**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE PAINTER, INC. TO PRESSURE CLEAN AND COMPLETE GENERAL PREVENTATIVE MAINTENANCE AT THE GUARDHOUSE/SUBSTATION BUILDING, INCLUDING MATERIALS AND LABOR AT A COST NOT TO EXCEED \$6,860.00; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, The Painter, Inc. is the sole source for particular paint materials used in the maintenance and upkeep of the Guardhouse/Substation.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Council hereby authorizes The Painter, Inc. to pressure clean all stucco walls and the cleaning, staining with a varnish stain, and finished with a marine varnish all wood trim and canopies of the guardhouse/substation building, including materials and labor at a cost not to exceed \$6,860.00 consistent with Exhibit "A" attached hereto. The Mayor is hereby authorized to execute an Agreement with The Painter, Inc. Such Agreement is subject to approval by the Town Attorney.

Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 4. Effective Date.</u> That this Resolution shall become effective immediately upon approval of the Town Council.
