RESOLUTION NO. 1550.03

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE DONATION OF AN OBSOLETE POLICE VEHICLE LIGHT BAR TO THE FRATERNAL ORDER OF POLICE DISTRICT 5 HISTORICAL POLICE EQUIPMENT COLLECTION; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town is presently storing obsolete overhead police emergency lights at the storage facility behind Town Hall; and

WHEREAS, the Town has received a request to donate an old police vehicle light bar to the Fraternal Order of Police District 5 historical police equipment collection; and

WHEREAS, the Town Council finds that the obsolete equipment has little or no apparent value; and

WHEREAS, the Fraternal Order of Police District 5 would benefit by adding this obsolete equipment to its collection.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town hereby authorizes the donation of an obsolete police vehicle light bar to the Fraternal Order of Police District 5 historical police equipment collection.

Section 2. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 4. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.


The Motion to adopt the foregoing resolution was offered by Councilmember Paruas seconded by Vice Mayor Iglesias and on roll call the following vote ensued:
