RESOLUTION NO. 1555.04

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING AND APPROVING THE TOWN TO ENTER INTO AN AGREEMENT WITH GRAPH-PLEX CORPORATION FOR REPLACEMENT OF EXISTING STREET AND DIRECTIONAL SIGNAGE IN THE TOWN OF GOLDEN BEACH IN AN AMOUNT NOT TO EXCEED \$80,000.00; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Golden Beach Code of Ordinances Sec. 2-266 provides alternate purchasing procedures provided the Town acquires goods, materials or services obtained from or through the Federal Government, State, County, or other municipalities from advertised bid lists or procedures adopted by competitive bidding; and

WHEREAS, as a result of procedures adopted by other local government entities, Graph-Plex Corporation submitted proposals and was selected by such entity to provide street and directional signage; and

WHEREAS, the Town Manager has determined that Graph-Plex Corporation submitted bids that qualify under Town Code Sec. 2-266.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Council hereby authorizes and approves the scope of work as contained in Exhibit "A" with Graph-Plex Corporation in an amount not to exceed \$80,000.00.

Section 2. That the Mayor is hereby authorized to enter into an Agreement with Graph-Plex Corporation for the replacement of the Town's street and directional signage. Said Agreement is subject to approval by the Town Attorney.

Section 3. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 4. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 5. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.




