A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE MAYOR AND TOWN MANAGER TO EXECUTE AN ADDENDUM TO THE MASTER LEASE AGREEMENT WITH MEARS MOTOR LEASING AND OTHER APPROPRIATE DOCUMENTS FOR THREE NEW POLICE VEHICLES AT A COST NOT TO EXCEED A TOTAL OF \$1,652.73 PER MONTH FOR A THREE YEAR PERIOD; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town has previously leased vehicles from Mears Motor Leasing pursuant to a Master Lease Agreement approved by the Town Council in Resolution 1474.03 on April 15, 2003; and

WHEREAS, the Police Department is in need of additional vehicles; and

WHEREAS, Mears Motor Leasing can provide three additional vehicles to meet the needs of the Police Department;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Mayor and Town Manager be, and they are hereby authorized to execute an addendum to the master lease agreement with Mears Motor Leasing and other appropriate documents for three new police vehicles at a cost not to exceed a total of \$1,652.73 per month for a three year period, a copy of which is attached as Exhibit "A" and incorporated herein as if set forth in full.

Section 2. The lease addendum and other appropriate documents shall be in a form acceptable to the Mayor and Town Attorney.

Section 3. Severability. That the provisions of this Resolution are declared to be severable

and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 4. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 5.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
