TO UPDATE THE STORMWATER MANAGEMENT MASTER PLAN PREPARED BY WILLIAMS, HATFIELD & STONER, INC., DATED MARCH 1996; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

#### Steve:

I have finally completed my review of the recent submittal of the City's March 1996. Stormwater Management Master Plan. Additional information is required to complete the SRF planning process. Please provide an update of the current status of the City's stormwater master plan. What work recommended in 1996 has been completed and what remains to be done? Frovide a clear description of the proposed construction including a detailed construction cost estimate, the proposed implementation schedule and good location maps. Please submit one signed and sealed copy of the master plan update along with a CD containing the same information. The information on the CD will be placed on the internet to facilitate the State Clearinghouse review. The location maps need to be in pdf.

The existing plan adequately covers the required alternatives evaluation. However, a few additional statements regarding the environmental consequences of the project are needed to complete my review checklist. Section III Questions 4, 6 and 7 of my checklist ask the following:

- \* What are the environmental benefits of the proposed project? (improved quality of the stormwater discharge to the Intracoastal?)
- \* Will the proposed project have any significant adverse environmental effects? (if none are expected, please state this)
- \* Will the proposed project have any sign: ficant adverse effect on minority or low-income communities? (if no, please state this)

The capital financing plan worksheets need to be completed and submitted. They do not have to be part of the stormwater plan update, they can be submitted later.

Public Farticipation: EPA requires that we obtain documentation that a public meeting was held to discuss the proposed project and its financial impact on the community. We will need a copy of the public meeting advertisement and a copy of the meeting minutes. The meeting should also include specific authorization (e.g. adopting resolution or Town Council

vote) to implement the planning recommendations.
