A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA TO ACCEPT THE BENEFIT PROPOSAL FOR LIFE INSURANCE PRESENTED BY STANDARD INSURANCE COMPANY AND AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town has sought bids for insurance services pursuant to the Town Code; and

WHEREAS, the Town Council has considered the responses and has determined that Standard Insurance Company is the lowest responsible bidder.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

- Section 1. That the Town hereby accepts the benefit proposal for life insurance presented by Standard Insurance Company.
- Section 2. That the Mayor is hereby authorized to negotiate, as necessary, and execute said Agreement on behalf of the Town of Golden Beach upon approval by the Town Attorney.
- <u>Section 3.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
- Section 4. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
