## **RESOLUTION NO. 1578.04**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA SUPPORTING CYSTIC FIBROSIS RESEARCH AND PREVENTION AND AUTHORIZING THE TOWN ADMINISTRATION TO MAKE A CONTRIBUTION ON BEHALF OF THE TOWN; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Cystic Fibrosis is a disease that impacts children and families; and

WHEREAS, the Aventura Marketing Council is sponsoring a Stars 4 Stars event to support Cystic Fibrosis research and prevention; and

WHEREAS, the Town Council has determined that a contribution to this function supports the philosophy of the Town and serves a public purpose;

## NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> The foregoing Whereas Clauses are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this resolution.

Section 2. That the Town Council of the Town of Golden Beach supports the efforts of the Aventura Marketing Council in its Stars 4 Stars event and authorizes the Town Administration to contribute \$500.00 as a sponsorship opportunity toward this event

Section 3. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
