A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING THE MAYOR AND POLICE CHIEF TO SIGN A MUTUAL AID AGREEMENT BETWEEN THE TOWN OF GOLDEN BEACH AND THE CITY OF HALLANDALE BEACH; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the continuing possibility exists that public safety concerns could cause the Chiefs of Police of the Town of Golden Beach or the City of Hallandale Beach to seek additional resources for law enforcement purposes on a short term basis; and,

WHEREAS, the Town of Golden Beach would benefit from an Agreement providing additional resources should the circumstances require additional law enforcement support;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> That the Mayor is hereby authorized to sign the Mutual Aid Agreement by and between the Town of Golden Beach and the City of Hallandale Beach, a copy of which is attached as Exhibit "A" and incorporated herein as if set forth in full.

<u>Section 2.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 3. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
