A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING AND APPROVING THE TOWN TO ENTER INTO AN AGREEMENT WITH NAVARRO SECURITY GROUP, INC. TO PROVIDE SECURITY SERVICES IN THE TOWN OF GOLDEN BEACH; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Golden Beach Code of Ordinances Sec. 2-266 provides alternate purchasing procedures provided the Town acquires goods, materials or services obtained from or through the Federal Government, State, County, or other municipalities from advertised bid lists or procedures adopted by competitive bidding; and

WHEREAS, as a result of procedures adopted by other local government entities, Navarro Security Group, Inc. submitted proposals and was selected by the City of Fort Lauderdale, Florida to provide security services; and

WHEREAS, the Town Manager has determined that Navarro Security Group, Inc. submitted bids that qualify under Town Code Sec. 2-266 and the services needed by the Town of Golden Beach are consistent with what was issued under the Request for Proposal issued by the City of Fort Lauderdale, Florida.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Council hereby authorizes and approves the use of Request for Proposal 222-8640 issued by the City of Fort Lauderdale and awarded to Navarro Security Group, Inc.

Section 2. That the Mayor is hereby authorized to enter into an Agreement with Navarro Security Group, Inc. Said Agreement is subject to approval by the Town Attorney.

<u>Section 3.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.

Section 4. Conflict. That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

<u>Section 5.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.

AGREEMENT BETWEEN TOWN OF GOLDEN BEACH AND NAVARRO SECURITY GROUP, INC.

OWNER and PROVIDER, in consideration of the mutual covenants hereinafter set forth, agree as follows:

Article 1. Work.

PROVIDER shall perform under and be bound by all the terms and conditions as specified or indicated in the Contract Documents under the City of Fort Lauderdale Contract No. 222-8640 (a copy of which is attached as Exhibit "A" and incorporated herein as if set forth in full) executed on July 16, 2002 which includes contract form G-110, Rev 12/00, the ITB/RFP and all addenda thereto and the Contractor's bid in response to the City's ITP/RFP except for the following modifications to which PROVIDER agrees to perform under and be bound by under the terms of this Agreement.

Article 2. MODIFICATIONS.

- 2.1 The "Town of Golden Beach" is substituted for the "City of Fort Lauderdale" throughout all documents prepared for and submitted in conjunction with and including the Contract between the City of Fort Lauderdale and the PROVIDER including, but not limited to, provisions addressing insurance requirements and indemnification.
- 2.2 Section 5.20 is modified to reflect venue in Miami-Dade County, Florida. The remainder of Section 5.20 remains unchanged.
- 2.3 PROVIDER will provide services under the terms and conditions of the City of Fort Lauderdale Contract No. 222-8640 for the Town of Golden Beach, Florida at its police substation located at The Strand and A1A. Any reference to locations in the City of Fort Lauderdale Contract No. 222-8640 is amended to refer to the Town of Golden Beach substation located at The Strand and A1A.
- 2.4 Reference to any contact number in the City of Fort Lauderdale Contract No. 222-8640 is amended to reflect the Town of Golden Beach, Florida c/o the Town Manager, One Golden Beach Drive, Golden Beach, FL 33160. Telephone: 305-932-0744.
- 2.5 Section 04. of Part I "Introduction/Information" is amended reflect that PROVIDER must be properly licensed in the State of Florida and hold correct licenses in Miami-Dade County and the Town of Golden Beach, as required.
- 2.6 Section 27 of Part I "Introduction/Information" remains the same with the understanding that the term of the contract period commences on the date this Agreement is fully executed

by the parties hereto.

2.7 The following sections of Part IV "Technical Specification/Scope of Services" is amended to read as follows (all parts not changed below remain the same save for incorporation of the terms of this Agreement as set forth):

SECURITY OFFICER EXPERIENCE AND QUALIFICATIONS

All personnel assigned to this contract shall be of high quality, properly trained and qualified to perform security services. All personnel shall be subject to advance approval by the Town's designated representative.

The contractor shall be responsible for deportment, appearance, conduct and supervision of all personnel concerned with the operation of this security service contract. All Contractor personnel will be required to conduct themselves in a completely professional, respectable manner, observe the doctrines of behavior as a public servant and be polite, courteous, cooperative, and pleasant in the conduct of their duties. Any security officer caught asleep or off their scheduled post shall be sent home immediately and a replacement security officer shall be called in.

SECURITY OFFICER LEVEL B CATEGORY REQUIRES THE FOLLOWING:

Experience, Training and Communication Skills:

Each Security Officer will have a complete background check made by the Contractor and the results of such checks shall be made available to the Town upon request.

- a. Shall be a U.S. citizen or have a valid resident alien status.
- b. Be a graduate of a certified United States sederal, state, county, or local law enforcement agency training program, a military police training program, or trained as a correctional officer.
- c. Be fully literate in the English language (i.e. be able to read, write, speak, understand, and be understood) Oral command of the English language must be sufficient to permit full communication, particularly in times of stress.
- d. Have a valid drivers license
- e. One-year experience in a responsible security position.
- f. High school diploma or equivalent.
- g. Successfully completed contractor training in the following skill areas:
 - o techniques and patrol
 - o first aid including CPR
 - o public relations
 - o safety
 - o proper use of telephones and radio
 - o proper use of written report forms.
 - o site hours and on site training by the supervisors of the contractor verified and documented by the Town.
- h. Shall not be considered for this contract if they currently or in the past been involved in:
 - Any felony or sex conviction
 - o Military conduct resulting in dishonorable or undesirable discharge.

o Any pattern of irresponsible behavior, including but not limited to unreasonable driving, or a problem employment record.

Physical Capabilities: Security officers must successfully pass a medical examination, conducted at the Contractor's expense, prior to duty assignment. The minimum requirements are as follows:

- a. Freedom from any communicable diseases.
- b. Binocular vision, which is correctable to 20/20 vision.
- c. Ability to distinguish shades of colors.
- d. Ability to hear ordinary conversation at a distance of 20 feet, without the use of artificial hearing devices.
- e. Freedom from drug use, except prescribed medication as evidenced by urinalysis test.
- f. Freedom from disease or condition that results in indistinct speech.
- g. Free from any physical or emotional disorder, or any hindrance that may inhibit or preclude meeting the professional standards required by the contract.
- h. Blood pressure and other vital signs must be within normal limits.

INITIAL SCOPE OF SERVICES:

The Town has a police department substation facility requiring security services with the area of operation. The facility is located at the entranceway of The Strand and A1A.

The initial scope of services will be to provide a midlevel stationary unarmed security officer to maintain the operations of the electronic gates at the ingress/egress areas of the roadway located at the substation facility. The security officer will maintain the Town's Substation phones and dispatch police officers to the proper locations for the calls received via phone and radio communication.

The contractor shall have the capacity to provide additional security officers, as may be required during the contract period. Such extra security services shall be billed to the Town at the same contract hourly rate.

Contractor shall be able to respond to the Town's requests for changes in hours of work, if such changes are required to provide adequate security for the Town facilities. Requests by the Town for additional coverage or a reduction in coverage at the above location must take place within 58 hours from the date of request. Such request may be initially made verbally or in person, which shall be the date of request, but the Town shall confirm the request in writing.

SERVICES AND EQUIPMENT PROVIDED BY THE TOWN

The Town shall make available to the headquarters of the Contractor one complete Standard Operating Procedures for the security officer's responsibilities. The Town shall make available a supply of forms for incident reporting or any other special reporting that the Town requires in a specific format that it prescribes.

SERVICES AND EQUIPMENT PROVIDED BY THE CONTRACTOR

Contractor is to provide the security officer, the uniform for the security officer, communications equipment for the officer, supervision of the security officer, and twenty-four (24) hour per day, seven days per week, communications access for the Town and security officer.

Contractor shall have a regular business office located in the tri-county area (Miami Dade, Broward, Palm Beach). The Contractor's dispatch facility shall be staffed by full-time employees of the Contractor at a location properly zoned for such activity.

The Security Officer must have communication equipment that will allow him/her to contact his office, the Police Chief, and/or Town Manager (i.e., radio, cellular phone, etc.)

The Security Officer will be neatly groomed, in the approved uniform and properly equipped. The security officer's uniform shall be clearly identified with the security firm's name and be identified with the Town's logo or other identification to notify the public that the Security Officer is providing the service for the Town. The Security Officer shall wear a nametag.

The Security Officer will report to the designated initial facility location on time and will remain on duty until the end of the shift or until properly relieved. No Security Officer will work more than a twelve (12) hour shift in a twenty-four (24) hour period.

The Security Officer will maintain a good personal and uniform appearance, be courteous to residents and visitors at the Substation facility and to Town personnel. The Security Officer will not conduct any personal activity that would detract from a professional image.

The Security Officer will greet the vehicles entering the non-resident traffic lane and offer assistance, directions, etc. to the visitor. The Security Officer will complete an "Incident Report" to be provided to the Corporal or his/her designee at the completion of the shift for any contract initiated by the Security Officer against unauthorized visitors or involving residents who may be reporting violations or suspicious activities or who's conduct on Town property may voluntarily or involuntarily warrant response from the Security Officer. The Incident Report shall also be completed even when reported activity involves response by the Town Police Officers to further document the circumstances and confirm that a Police Report is in the process of being made.

The Security Officer will contact the appropriate party when such events occur or have occurred. The Corporal of the shift should be contacted in routine or non-routine cases. The Town of Golden Beach's police officer and the Security Officer's supervisor must be immediately contacted in emergency situations or when assistance is thought to be needed. It is not expected that the Security Officer will enter into a direct confrontation with persons at the facility.

The Security Officer will report safety hazards, malfunctioning equipment or other such matters to the Corporal on-duty.

The Security Officer will maintain a daily logbook, recording all instances that may be of interest to Supervisors and Town personnel.

A Security Firm Supervisor will visit the Security Officer at least once during each shift to insure that the Security Officer is following proscribed procedures. Such visits are to be entered in the logbook. The Security Firm supervisor shall visit all of the facilities at least once each week to familiarize himself with their condition and any possible safety or security problems or potential problems. The supervisor, or other qualified personnel approved by the Town shall take over for the Security Officer during any meal or other breaks when the Officer is not observing the site.

THE POST OPERATING ORDERS:

The Town reserves the right to establish in writing with the Contractor more detailed written policies and procedures governing the Security Officer(s) and the Firm requirements for reporting observations, incidences to the Town Police Department or other emergency contact personnel. Such additional written policies and procedures are for the purposes of enhancing compliance with the technical specifications of the contract and not to alter them, and may be amended from time to time to adjust for changing circumstances.

PENALTY:

The Town shall assess the Contractor a \$100.00 penalty for each hour, or part thereof, that there is a lack of security coverage at the designated site, by any guard for any reason except "force majeure", and until such time as a security officer arrives on duty.

- 2.8 Notwithstanding language to the contrary, the TOWN reserves the right to cancel this Agreement in its sole discretion and as determined by the TOWN upon 30 days written notice to PROVIDER prior the effective date of such cancellation. TOWN's obligation will be limited to compensating PROVIDER through the last day of service only. PROVIDER agrees that it has no further recourse against the TOWN in any forum, including but not limited to any administrative body or court (county, state or federal) should the TOWN exercise its option to cancel this Agreement
- Any provisions or part of the Contract Documents held to be void or unenforceable under any Law or Regulation shall be deemed stricken, and all remaining provisions shall continue to be valid and binding upon TOWN and PROVIDER, who agree that the Contract Documents shall be reformed to replace such stricken provisions or part thereof with a valid and enforceable provision that comes as close as possible to expressing the intention of the stricken provision.

IN WITNESS WHEREOF, the parties hereto have made and executed this Agreement on the respective dates under each signature: PROVIDER, through its President and the Town of Golden Beach through its Town Council, signing by and through its Mayor, authorized to execute same by Council action on the 20 day of _______, 2004.

PART | BIDDER PROPOSAL PAGE(S) CONDITIONS:

- BIDDER ADDRESS: The City maintains automated vendor mailing lists for each apecific Commodity Class Item. Invitation to Bid (ITB'S) will be mailed first to a selection of Bidders who have fully registered on our system. Requests will be mailed to unregistered Bidders within a reasonable time frame for that bid only. Neither the mailing of one ITB to the vendor, nor a bid in return, will register a vendor on our system. If you wish purchase orders sent to a different address, please so indicate. If you wish payments sent to a different address, please so indicate on your invoice.
- DELIVERY: Time will be of the essence for any orders placed as a result of this ITB. The City reserves the right to cancel any orders, or part 1.02 thereof, without obligation if delivery is not made in accordance with the schedule specified by the Bidder and accepted by the City,
- PAYMENT TERMS AND CASH DISCOUNTS: Payment terms, unless otherwise stated in this ITB, will be considered to be not 30 days after 1.03 the date of satisfactory delivery at the place of acceptance and receipt of correct invoice at the office specified, whichever occurs last. Bidder may offer cash discounts for prompt payment but they will not be considered in determination of award. Par II DEFINITIONS/ORDER OF PRECEDENCE:
2.01 BIDDING DEFINITIONS: The City will use the following definitions in it's general conditions, special conditions, technical specifications, instructions to bidders, addends and any other document used in the bidding process:

INVITATION TO BID (ITB) when the City is requesting bids from qualified Bidders.

REQUEST FOR PROPOSALS (RFP) when the City is requesting proposals from qualified Proposers.

BID - a price and terms quote received in response to an ITB.

PROPOSAL - a proposal received in response to an RFP.

BIDDER - Person or firm submitting a Bid.

PROPOSER - Person or firm submitting a Proposal.

RESPONSIVE BIDDER - A person whose bid conforms in all material respects to the terms and conditions included in the ITB.

RESPONSIBLE BIDDER - A person who has the capability in all respects to perform in full the contract requirements, as stated in the ITB, and the integrity and reliability that will assure good faith performance.

FIRST RANKED PROPOSER - That Proposer, responding to a City RFP, whose Proposal is docined by the City, the most advantageous to the City after applying the evaluation criteria contained in the RFP.

SELLER - Successful Bidder or Proposer who is awarded a Purchase Order or Contract to provide goods or services to the City.

CONTRACTOR - Successful Bidger or Proposer who is awarded a Purchase Order, award Contract, Blanket Purchase Order agreement, or Term Contract to provide goods or services to the City.

CONTRACT - A deliberate verbal or written agreement between two or more competent parties to perform or not to perform a certain act or acts, including all types of agreements, regardless of what they may be called, for the procurement or disposal of equipment, materials, supplies, services or construction.

CONSULTANT - Successful Bidder or Proposer who is awarded a contract to provide professional services to the City.

The following terms may be used interchangeably by the City: ITB, or RFP; Bid or Proposal; Bidder, Proposer, or Seller, Contractor or Consultant; Contract, Award, Agreement, or Purchase Order.

SPECIAL CONDITIONS: Any and all Special Conditions contained in this ITB that may be in variance or conflict with these General 2.02 Conditions shall have precedence over these General Conditions. If no changes or deletions to General Conditions are made in the Special Conditions, then the General Conditions shall provail in their entirely,

PART III BIDDING AND AWARD PROCEDURES:

- SUBMISSION AND RECEIPT OF BIDS: To receive consideration, blds must be received prior to the bid opening date and time. Unless otherwise specified, Bidder's should use the proposal forms provided by the City. These forms may be duplicated, but failure to use the forms may cause the bid to be rejected. Any grasures or corrections on the bid must be made in lnk and initialed by Bidder in ink. All information submitted by the Bidder shall be printed, typewritten or filled in with pen and ink. Bids shall be signed in link. Separate bids must be submitted for each ITB lasted by the City in separate sealed shvolopes properly marked. When a particular ITB or RFP requires multiple copies of bids or proposals they may be included in a single envelope or package properly sealed and identified. Only send bids via facsimile transmission (FAX) if the ITB specifically states that bids sent via FAX will be considered. If such a statement is not included in the #TB, bids sent via FAX will be rejected. Bids will be publicly opened in the Purchasing Office, or other designated area, in the presence of Bidder's, the public, and City staff. Bidders and the public are invited and encouraged to attend bid openings. Bids will be tabulated and made available for review by Bidder's and the public in accordance with applicable regulations.
- MODEL NUMBER CORRECTIONS: If the model number for the make specified in this ITB is incorrect, or no longer available and replaced 3.02 with an updated model with new specifications, the Bidder shall enter the correct model number on the bidder proposal page. In the case of an updated model with new specifications, Bidder shall provide adequate information to allow the City to determine if the model bid meets the City's requirements.
- 3.03 PRICES QUOTED: Deduct trade discounts, and quote firm net prices. Give both unit price and extended total. In the case of a discrepancy in computing the amount of the bid, the unit price quoted will govern. All prices quoted shall be F.O.B. destination, freight prepaid (Bidder pays and bears freight charges, Bidder owns goods in transit and files any claims), unless otherwise stated in Special Conditions. Each item must be bid separately. No attempt shall be made to tie any item or items contained in the ITB with any other business with the City.
- 3.04 TAXES: The City of Fort Lauderdate is exempt from Federal Excise and Florida Sales taxes on direct purchase of tangible property. Exemption number for Federal Exclae taxes is 59-74-0111K, and State Sales tax exemption number is 16-03-196479-54C.
- WARRANTIES OF USAGE: Any quantities listed in this ITB as estimated or projected are provided for tabulation and information purposes 3.05 only. No warranty or guarantee of quantities is given or implied. It is understood that the Contractor will furnish the City's needs as they

- APPROVED EQUAL: When the technical specifications call for a brand name, manufactoris, make, model, or vendor catalog number with acceptance of APPROVED EQUAL, it shall be for the purpose of establishing a level of quality and features desired and acceptable to the City. In such cases, the City will be receptive to any unit that would be considered by qualified City personnel as an approved equal. In that the specified make and model represent a level of quality and features desired by the City, the Bidder must state clearly in his bid any variance from those specifications. It is the Bidder's responsibility to provide adequate information, in his bid, to enable the City to ensure that the bid meets the required criteria. If adequate information is not aubmitted with the bid, it may be rejected. The City will be the sole judge in determining if the item bid qualifies as an approved equal.
- 3.07 MINIMUM AND MANDATORY TECHNICAL SPECIFICATIONS: The technical specifications may include items that are considered minimum, mandatory, or required. If any Bidder is unable to meet, or exceed these items, and feels that the technical specifications are overly restrictive, he must notify the Purchasing Division immediately. Such notification must be received by the Purchasing Division prior to the deadline contained in the ITB, for questions of a material nature, or prior to five (5) days before bid due and open date, whichever occurs first. If no such notification is received prior to that deadline, the City will consider the technical specifications to be acceptable to all bidders.
- 3.08 MISTAKES: Bidders are cautioned to examine all terms, conditions, specifications, drawings, exhibits, addenda, delivery instructions and special conditions pertaining to the ITB. Failure of the Bidder to examine all pertinent documents shall not entitle him to any relief from the conditions imposed in the contract.
- 3.09 SAMPLES AND DEMONSTRATIONS: Samples or inspection of product may be requested to determine suitability. Unless otherwise specified in Special Conditions, samples shall be requested after the date of bid opening, and if requested should be received by the City within seven (7) working days of request. Samples, when requested, must be furnished free of expense to the City and if not used in testing or destroyed, will upon request of the Bidder, be returned within thirty (30) days of bid award at Bidder's expense. When required, the City may request full demonstrations of units prior to award. When such demonstrations are requested, the Bidder shall respond promptly and arrange a demonstration at a convenient location. Fallure to provide samples or demonstrations as specified by the City may result in rejection of a bid.
- 3.10 LIFE CYCLE COSTING: If so specified in the ITB, the City may elect to evaluate equipment proposed on the basis of total cost of ownership. In using Life Cycle Costing, factors such as the following may be considered: estimated useful life, maintenance costs, cost of supplies, labor intensity, energy usage, environmental impact, and residual value. The City reserves the right to use those or other applicable criteria, in its sole opinion, that will most accurately estimate total cost of use and ownership.
- BIDDING ITEMS WITH RECYCLED CONTENT: In addressing environmental concerns, the City of Fort Lauderdale encourages Bidders to submit bids or alternate bids containing items with recycled content. When submitting bids containing items with recycled content, Bidder shall provide documentation adequate for the City to verify the recycled content. The City prefers packaging consisting of materials that are degradable or able to be recycled. When specifically stated in the ITB, the City may give preference to bids containing items manufactured with recycled material or packaging that is able to be recycled.
 - USE OF OTHER GOVERNMENTAL CONTRACTS: The City reserves the right to reject any part or all of any bids received and utilize other available governmental contracts, if such action is in its best interest.
- 3.13 QUALIFICATIONS/INSPECTION: Bids will only be considered from firms normally engaged in providing the types of commodities/services specified herein. The City reserves the right to inspect the Bidder's facilities, equipment, personnel, and organization at any time, or to take any other action necessary to determine Bidder's ability to perform. The Purchasing Manager reserves the right to reject bids where evidence or evaluation is determined to indicate inability to perform.
- 3.14 BID SURETY: If Special Conditions require a bid security, it shall be submitted in the amount stated. A bid security can be in the form of a bid bond, postal money order, cashiers check, or irrevocable letter of credit. Bid security will be returned to the unsuccessful bidders as soon as practicable after opening of bids. Bid security will be returned to the successful bidder after acceptance of the performance bond or irrevocable letter of credit, if required; acceptance of insurance coverage, if required; and full execution of contract documents, if required; or conditions as stated in Special Conditions.
- PUBLIC RECORDS: Florida law provides that municipal records shall at all times be open for personal inspection by any person. Section 119.01, F.S., The Public Records Law. Information and materials received by City in connection with an ITB response shall be deemed to be public records subject to public inspection upon award, recommendation for award, or 10 days after bid opening, whichever occurs first. However, certain exemptions to the public records law are statutorily provided for in Section 119.07, F.S. If the Proposer believes any of the information contained in his or her response is exempt from the Public Records Law, then the Proposer, must in his or her response, specifically identify the material which is deemed to be exempt and cite the legal authority for the exemption, otherwise, the City will treat all materials received as public records.
- 3.16 PROHIBITION OF INTEREST: No contract will be awarded to a bidding firm who has City elected officials, officers or employees affiliated with it, unless the bidding firm has fully compiled with current Florida State Statutes and City Ordinances relating to this issue. Bidders must disclose any such affiliation. Failure to disclose any such affiliation will result in disqualification of the Bidder and removal of the Bidder from the City's bidder lists and prohibition from engaging in any business with the City.
- RESERVATIONS FOR AWARD AND REJECTION OF BIDS: The City reserves the right to accept or reject any or all bids, part of bids, and to waive minor irregularities or variations to specifications contained in bids, and minor irregularities in the bidding process. The City also reserves the right to award the contract on a split order basis, lump sum basis, individual item basis, or such combination as shall best serve the interest of the City. The City reserves the right to make an award to the responsive and responsible bidder whose product or service meets the terms, conditions, and specifications of the ITB and whose bid is considered to best serve the City's interest. In determining the responsiveness of the offer and the responsibility of the Bidder, the following shall be considered when applicable: the ability, capacity and skill of the Bidder to perform as required; whether the Bidder can perform promptly, or within the time specified, without delay or interference; the character, integrity, reputation, judgment, experience and efficiency of the Bidder; the quality of past performance by the Bidder; the previous and existing compliance by the Bidder with related laws and ordinances; the sufficiency of the Bidder's financial resources; the availability, quality and adaptability of the Bidder's supplies or services to the required use; the ability of the Bidder to provide future maintenance, service or parts; the number and scope of conditions attached to the bid.

If the ITB provides for a contract trial period, the City reserves the right, in the event the selected bidder does not perform satisfactorily, to award a trial period to the next ranked bidder or to award a contract to the next ranked bidder, if that bidder has successfully provided services to the City in the past. This procedure to continue until a bidder is selected or the contract is re-bid, at the sole option of the City.

LEGAL REQUIREMENTS: Applicable p 3.18 ions of all federal, state, county laws, and locr 'inances, rules and regulations, shall govern i any and all claims and disputes which may I blds received in response hereto and shall gu development, submittal and evaluation. arise between person(s) submitting a bid response hereto and the City by and through its officers, employees and authorized representatives, or any other person, natural or otherwise; and lack of knowledge by any bidder shall not constitute a cognizable defense against the legal effect thereof.

RT IV BONDS AND INSURANCE

PERFORMANCE BOND/IRREVOCABLE LETTER OF CREDIT: If a performance bond or Irrevocable letter of credit is required in Special Conditions, the Contractor shall within fifteen (15) working days after notification of award, furnish to the City a Performance Bond or an Unconditional Irrevocable Letter of Credit payable to the City of Fort Lauderdale, Florida, in the face amount specified in Special Conditions as surely for faithful performance under the terms and conditions of the contract. Any substitutes or material not meeting specifications will be returned at the Bidder's expense. Payment will be made only after City receipt and acceptance of materials or services.
- SAFETY STANDARDS: All manufactured items and fabricated assemblies shall comply with applicable requirements of the Occupational 5 03 Safety and Health Act of 1970 as amended, and be in compliance with Chapter 442, Florida Statutes. - INDEMNITY/HOLD HARMLESS AGREEMENT: The Contractor agrees to protect, defend, indemnify, and hold harmless the City of Fort 5.08 Lauderdale and its officers, employees and agents from and against any and all losses, penalties, damages, settlements, claims, costs, charges for other expenses, or liabilities of every and any kind including attorney fees, in connection with or arising directly or indirectly out of the work agreed to or performed by Contractor under the terms of any agreement that may arise due to the bidding process. Without limiting the foregoing, any and all such claims, suits, or other actions relating to personal injury, death, damage to property, defects in materials or workmanship, actual or alleged violations of any applicable Statute, ordinance, administrative order, rule or regulation, or decree of any court shall be included in the

- 5.09 TERMINATION FOR CAUSE: If, through any cause, the Contractor shall fall to fulfill in a whely and proper manner its obligations under this Agreement, or if the Contractor shall violate any of the provisions of this Agreement, the City may upon written notice to the Contractor terminate the right of the Contractor to proceed under this Agreement, or with such part or
 - parts of the Agreement as to which there has been default, and may hold the Contractor liable for any damages caused to the City by reason of such default and termination. In the event of such termination, any completed services performed by the Contractor under this Agreement shall, at the option of the City, become the City's property and the Contractor shall be entitled to receive equitable compensation for any work completed to the satisfaction of the City. - RECORDS/AUDIT: The Contractor shall maintain during the term of the contract all books of account, reports and records in accordance with generally accepted accounting practices and standards for records directly related to this contract. The Contractor agrees to make available to the City's Internal Auditor, during normal business hours and in Broward, Dade or Palm Beach Countles, all books of account, reports and records relating to this contract for the duration of the contract and retain them for a minimum period of one (1) year beyond the last day of the contract term.

The City may, after examination, refuse to accept the adjusted costs if they are not properly documented, increases are considered to be excessive, or decreases are considered to be insufficient. The City shall not be liable for any costs incurred by proposers in responding to this RFP.

06. RULES AND PROPOSALS

The signer of the proposal must declare that the only person(s), company or parties interested in the proposal as principals are named therein; that the proposal is made without collusion with any other person(s), company or parties submitting a proposal; that it is in all respects fair and in good faith, without collusion or fraud; and that the signer of the proposal has full authority to bind the principal proposer.

07 FAMILIARITY WITH LAWS

All proposers are required to comply with all Federal, State and Local Laws, Codes, Rules and Regulations that govern and control the actions and operations of this proposal.

08. CONFLICT OF INSTRUCTIONS

If a conflict exists between the General Conditions and instructions contained herein, and the Specific Conditions and instructions contained herein, the specifics shall govern.

09. CONFIDENTIAL INFORMATION

Florida law provides that municipal records shall at all times be open for personal inspection by any person. Section 119.01, F.S., The Public Records Law. Information and materials received by City in connection with all Proposer's response shall be deemed to be public records subject to public inspection upon award, recommendation for award or 10 days after bid opening, whichever occurs first. However, certain exemptions to the public records law are statutorily provided for in Section 119.07,

09. CONFIDENTIAL INFORMATION (Cont.)

F.S. Therefore, if the Proposer believes any of the information contained in his or her response is exempt from the Public Records Law, then the Proposer must in his or her response specifically identify the material that is deemed to be exempt and cite the legal authority for the exemption, otherwise, the City will treat all materials received as public records.

10. PUBLIC ENTITY CRIMES

A person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not submit a bid on a contract with a public entity for the construction or repair of a public building or public work, may not submit bids on leases of real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017, Florida Statutes, for Category Two for a period of 36 months from the date of being placed on the convicted vendor list.

NOTE: Proposer, by submitting a proposal attests they have not been placed on the convicted vendor list.

11. INVOICES/PAYMENT

The City will accept invoices no more frequently than once per month. Each invoice shall fully detail the hourly costs and all related costs and shall specify the status of the particular task or project as of the date of the invoice as regards the accepted schedule for that task or project. The City will endeavor to make payment on a correct invoice within thirty (30) days after receipt of an invoice acceptable to the City.

Any amount owed to the City by the Contractor due to damage or loss of equipment, property, etc. shall be deducted from the Contractors invoice submitted for the period in which the loss / damage took place.

12. CONTRACT COST ADJUSTMENTS

The costs as proposed and accepted by the City shall be firm for the initial contract term. The costs for subsequent terms shall be subject to an adjustment only if increases or decreases have occurred in the industry and are properly documented. Any requested cost adjustment shall be submitted to the City at least sixty (60) days prior to the contact anniversary date.

The City may, after examination, refuse to accept the adjusted costs if they are not properly documented, increases are considered to be excessive, or decreases are considered to be insufficient. In the event the City does not wish to accept the adjusted costs, and the matter cannot be resolved to the satisfaction of the City, the City reserves the right to cancel the contract upon giving thirty (30) days notice to the Contractor.

13. RELATED EXPENSES

All related expenses chargeable to the City, such as supplies, printing, binders, etc shall be passed through at Contractor's cost. Related expenses shall not include any postage, telephone toll charges, or other charges incurred in the normal course of business.

14. TAXES AND PERMITS:

The State, any county, municipality or political subdivision of this State is exempt from the sales tax, except this exemption shall not include sales of tangible personal property made to contractors employed either directly or as agents of any such government or political subdivision thereof when such tangible personal property goes into or becomes a part of public works owned by such government or political subdivision thereof. The bidder shall take these factors into consideration in preparing his proposal, including therein the cost of the State and Use Tax on materials, but excluding the cost of those taxes and permits not applicable.

15. NO EXCLUSIVE CONTRACT / ADDITIONAL SERVICES

- 15.1 Contractor agrees and understands that the contract shall not be construed as an exclusive arrangement and further agrees that the City may, at any time, secure similar or identical services at its sole option.
- 15.2 While this contract is for services provided to the City's Marine Facilities
 Department, the City may require similar work for other City departments. Contractor
 agrees to take on such work unless such work would not be considered reasonable or
 become an undue burden to the Contractor.
- 15.3 The City may require additional items or services of a similar nature, but not specifically listed in the contract. The Contractor agrees to provide such items or services, and shall provide the City prices on such additional items or services based upon a formula or method that is the same or similar to that used in establishing the prices in his proposal. If the price(s) offered are not acceptable to the City, and the situation cannot be resolved to the satisfaction of the City, the City reserves the right to procure those items or services from other vendors, or to cancel the contract upon giving the Contractor thirty (30) days written notice.

16. CANCELLATION

In the event that any of the provisions of the contract are violated by the successful bidder, the City may serve written notice upon such bidder of its intention to terminate the contract, and, unless ten (10) days after serving such notice upon the contractor, such violation shall cease and satisfactory arrangements for correction be made, the contract shall, upon expiration of said ten (10) days, cease and terminate, but the liability of such bidder and his surety for any and all such violations shall not be affected by any such termination.

17. MODIFICATION OF SERVICES (Deletions / Additions)

The City reserves the right to delete any portion of this Contract at any time without cause, or add additional services, and if such right is exercised by the City, the total fee shall be reduced/added in the same ratio as the estimated cost of the work deleted/added bears to the estimated cost of the work originally planned. If work has already been accomplished on the portion of the Contract to be deleted, the Contractor shall be paid for the deleted portion on the basis of the estimated percentage of completion of such portion. The contract agrees to accommodate the City for any reasonable adjustment in the scope of service.

18. SELLING, TRANSFERRING OR ASSIGNING CONTRACTS

No contract awarded under these terms, conditions and specifications shall be sold, transferred or assigned without the written approval of The City of Fort Lauderdale.

19. SUBCONTRACTING

The use of subcontractors will not be allowed by the primary contractor, unless there are special circumstances approved by the city. It is the intent of this contract to require the primary contractor to provide all services required.

20. SUBSTITUTION OF PERSONNEL

It is the intention of the City that the Contractor's management or supervisory personnel proposed for the contract will be available for the initial contract term. In the event the Contractor wishes to substitute personnel, he shall propose personnel of equal or higher qualifications and all replacement personnel are subject to prior City approval. In the event substitute personnel are not satisfactory to the City and the matter cannot be resolved to the satisfaction of the City, the City reserves the right to cancel the Contract for cause. See Section 5.09 General Conditions.

21. INDEPENDENT CONTRACTOR

The Contractor is an independent contractor under this Agreement. Personal services provided by the Contractor shall be by employees of the Contractor and subject to supervision by the Contractor, and not as officers, employees, or agents of the City. Personal policies, tax responsibilities, social security, health insurance, employee benefits, purchasing policies and other similar administrative procedures applicable to services rendered under this Contract shall be those of the Contractor.

22. DEFAULT PROVISIONS

In the event of default by the Proposer, the City reserves the right to procure the item(s) / services proposed from other sources and hold the proposer responsible for excess cost incurred as a result. A contractor who defaults on a City contract may be banned from doing business with the City for a period of 36 months from the date of default.

23. INSURANCE

The Contractor shall not commence operations pursuant to the terms of this Agreement until certification or proof of insurance, detailing terms and provisions of coverage, has been received and approved by the City of Fort Lauderdale Risk Manager.

The contractor shall provide, pay for, and maintain in force at all time during the term of the contract, the following insurance coverage:

- a) Workers' Compensation Insurance covering all employees and providing benefits as required by Florida Statute, Chapter 440, regardless of the size of the company (number of employees). The Contractor further agrees to be responsible for employment, control and conduct of its employees and for any injury sustained by such employees in the course of their employment.
- b) <u>Liability Insurance</u> Naming the City of Fort Lauderdale as an additional insured, on General Liability Insurance only, in connection with the work being done under this contract.
- c) <u>Commercial General Liability</u>: Minimum limits of \$5,000,000.00 per occurrence combined single limit for Bodily Injury Liability and Property Damage Liability.
- d) <u>Automobile Liability Insurance:</u> Limits Bodily Injury of \$250,000 each person, \$500,000 each occurrence; Property Damage of \$100,000 per occurrence.

23. INSURANCE (Cont.)

The successful Proposer shall furnish to the City the certification or proof of insurance required by the provisions set forth above, within five (5) days after notification of award of contract.

Any questions as to the intent or meaning of any part of the above-required coverage should be directed to Mr. Scott Denham, Risk Manager, at (954) 761-5178.

24. TORT IMMUNITY:

The City of Fort Lauderdale hereby reserves to itself any and all tort immunity as provided to it by the laws of the State of Florida. It is hereby agreed that the City's liability is limited to the extent permitted by the Florida Constitution and Florida Statute 768.28 or any amendments thereto.

25. INDEMNITY/HOLD HARMLESS AGREEMENT

The Contractor agrees to protect, defend, indemnify, and hold harmless the City of Fort Lauderdale and its officers, employees and agents from and against any and all losses, penalties, damages, settlements, claims, costs, charges for other expenses, or liabilities of every and any kind including attorney fees, in connection with or arising directly or indirectly out of the work agreed to or performed by Contractor under the terms of any agreement that may arise due to the bidding process. Without limiting the foregoing, any and all such claims, suits, or other actions, relating to personal injury, death, damage to property, defects in materials or workmanship, actual or alleged violations of any applicable statute, ordinance, administrative order, rule or regulation, or decree of any court, shall be included in the indemnity hereunder.

26. DAMAGE TO PUBLIC, PRIVATE, AND/OR CITY PROPERTY

Extreme care shall be taken to safeguard all existing facilities, site amenities, irrigation systems, windows, and vehicles on or around the job site. Damage to public and/or private properly shall be the responsibility of the Contractor and shall be repaired and/or replaced at no additional cost to the City.

Extreme care shall be taken to safeguard any devices, components, tools, etc. owned by the City but distributed to the contractor during the course of their duties – this shall include, but not be limited to: The Electronic Cart, The Police Radio(s), The electronic time keeping devices or wands, and touch button and/or bar code readers to be placed in the vicinity of each slip that may be used as check points for guards. Damage to or loss of any city property used by the Contractor shall be repaired and/or replaced at the contractors expense with no charge-backs or additional charges to the City.

27. CONTRACT PERIOD:

The initial contract term shall commence upon final execution of the contract by the City and shall be for a Two (2) year period. The City may re-bid this contract after the initial two year period in an effort to combine all City security services into one contract. However, the City reserves the right to extend the contract for additional one (1) year terms providing all terms conditions and specifications remain the same, both parties agree to the extension, and such extension is approved by the City. Contract shall not be extended more than a total of five years.

28. ANTI-COLLUSION STATEMENT

By submitting this proposal, the Proposer affirms that this proposal is without previous understanding, agreement, or connection with any person, business, or corporation submitting a proposal for the same materials, supplies, or equipment, and that this proposal is in all respects fair, and without collusion or fraud.

PART IV - TECHNICAL SPECIFICATIONS / SCOPE OF SERVICES

01. GENERAL INFORMATION / INTENT

It is the intent of this section to establish several levels of Security Officer experience, training and abilities and to define the City's current needs for security officer services at our marine facilities. While the City currently plans to use Security Officer Level B on a roving basis for the New River Marginal Docking Facility and the Las Olas Municipal Marina and Anchorage, and stationary armed guard services for the Cooley's Landing Marina, we reserve the right to change the level of the officers, and the hours of coverage, etc. The City wants to have a multi year contract with a qualified Contractor that has the flexibility to adjust to the City's then current needs.

While this RFP is intended to result in a contract for a specific purpose for our marine facilities, it is also intended to result in a contract that will be available for other city departments or City uses as they may occur.

02. SECURITY OFFICER EXPERIENCE AND QUALIFICATIONS

All personnel assigned to this contract shall be of high quality, properly trained and qualified to perform airport security services. All personnel shall be subject to advance approval by the City designated representative.

The Contractor shall be responsible for deportment, appearance, conduct and supervision of all personnel concerned with the operation of this security service contract. All Contractor personnel will be required to conduct themselves in a completely professional, respectable manner, observe the doctrines of behavior as a public servant and be polite, courteous, cooperative and pleasant in the conduct of their duties. Any guard caught asleep or off of their scheduled post / grounds shall be sent home immediately and a replacement guard shall be called in.

GUARDS ARE TO BE CATOGORIZED AS FOLLOWS:

LEVEL A - BASE LEVEL

Experience, Training and Communication.

Each Security Officer will have a complete background check made by the Contractor and the results of such checks shall be made available to the City upon request.

- Shall be U.S. citizens or have a valid resident alien status.
- b. Be a graduate of a certified United States federal, state, county or local law enforcement agency training program, a military police training program, or trained as a correctional officer.

LEVEL A - BASE LEVEL(Cont.)

- c. Be fully literate in the English language (i.e., be able to read, write, speak understand and be understood) Oral command of the English language must be sufficient to permit full communication, particularly in times of stress.
- d. Have a valid drivers license.
- e. One years experience in a responsible security position.
- f. High school diploma or equivalent.
- g. Successfully completed contractor training in the following: technique and patrol, first aid including CPR, public relations, safety, proper use of telephones and radio, proper use of written report forms, sight hours on site training by supervisor of the contractor verified and documented by the City.
- h. Shall not be considered for this contract if they currently or in the past been involved in: (a) any felony or sex conviction, (b) military conduct resulting in dishonorable or undesirable discharge, (c) any pattern of irresponsible behavior, including but not limited to unreasonable driving, or a problem employment record.

Physical Capabilities: Security Officers must successfully pass a medical examination, conducted at the Contractors expense, prior to duty assignment. The minimum requirements are as follows:

- a. Freedom from any communicable disease.
- b. Binocular vision, which is correctable to 20/20 vision.
- c. Ability to distinguish shades of colors.
- d. Ability to hear ordinary conversation at a distance of 20 feet, without the use of artificial hearing devices.
- e. Freedom from drug use, except prescribed medication as evidenced by urinalysis test.
- f. Freedom from disease or condition that results in indistinct speech.
- g. Free from any physical or emotional disorder or any hindrance that may inhibit or preclude meeting the professional standards required by the contract.
- h. Blood pressure and other vital signs must be within normal limits.

LEVEL B - MID LEVEL

Meet all the requirements of Level A and have a minimum of two (2) years satisfactory experience as a full time military or civilian law enforcement officer. Service as a part time police officer, reserve officer, or part time security officer does not meet this criteria.

LEVEL C - HIGH LEVEL

Meet all the requirements of Level B and have the training qualifications and licenses to provide armed security officer services. This includes State of Florida Officer's "G" license and complete background check including felony screening in both the State of Florida and a national check by the FBI. The City will review all background materials on a person proposed for this level.

03. INITIAL SCOPE OF SERVICES

The City has three (3) marina facilities requiring security and patrol services within their area of operations. They are:

- Cooley's Landing Marina 450 Southwest 4th Avenue
- New River Marginal Docks
 2 South New River Drive
- Las Olas Marina and Anchorage 240 Las Olas Circle

The initial scope of services will be to provide:

- 1). A Level C stationary armed Security Officer at the Cooley's Landing Marina,
- 2). A Level B roving (via vehicle and foot patrol) Security Officer to cover the New River Marginal Docks, and the Las Olas Marina and Anchorage marine facilities.

The office and facilities for the Cooley's Landing Marina are located at 450 Southwest 4th Avenue. The marina is located within a public park. It contains approximately 30 slips and two boat ramps located on both sides of the Marshall Bridge as well as an office and a comfort facility. The New River Marginal Docks are located on the north side of the river from the Cooley's Landing Marina to SE 5th Ave. and on the south side of the river from SW 7th Ave to SW 4th Ave and from SW 1st Ave to the Federal Highway Tunnel. There are approximately 100 slips located on both sides of the New River. The office as well as the headquarters for all Marine Facilities operations is located at 2 South New River Drive. The office for the Las Olas Marina and the Las Olas Anchorage is located at 240 Las Olas Circle. The Las Olas Marina contains approximately 60 slips located on both sides of the Las Olas Bridge along the east bank of the Intracoastal Waterway as well as an office and a comfort facility. The office also serves currently as headquarters for the Fort Lauderdale Police Department's Beach Substation. The Las Olas Anchorage contains 10 buoy moorings and is located in the Las Olas Bight, south of the Las Olas Bridge on the west bank of the Intracoastal Waterway.

Cooley's Landing Marina: One stationary armed officer will be on duty seven (7) days per week. Depending on the cost per hourly service, coverage will be from 8:00 PM to 6:00 AM (10 hours – one shift) or from 4:00 PM to 8:00 AM (16 hours – two shifts).

New River Marginal Docks and Las Olas Marina and Anchorage: One roving officer with vehicle will be on duty seven (7) days per week from 10:00 PM to 6:00 AM (8 hours – one shift).

03. INITIAL SCOPE OF SERVICES (Cont.)

Contractor shall have the capacity to provide additional security guards, as may be required during the contract period. Such extra guard services shall be billed to the City at the same contract hourly rate.

Contractor shall be able to respond to City requests for changes in hours of work, if such changes are required to provide adequate security for the Marine facilities.

Requests by the City for additional coverage or a reduction in coverage at the above locations must take place within 48 hours from the date of request. Such requests may be initially made verbally or in person, which shall be the date of request, but the request shall be confirmed in writing by the City.

04. SERVICES AND EQUIPMENT PROVIDED BY CITY

The City shall make available to the headquarters of the Contractor one complete faxed copy of its stip inventory for all marine facilities included under this contract as of the close of business for each day of service provided, and an original copy will be left at the office for each area of operation that services are provided. The City shall also make available a supply of forms for incident reporting or any other special reporting that the City requires in a specific format that it prescribes.

At the Cooley's Landing Marina, the City shall provide at its expense a motorized cart to aide in the patrolling of that facility. The contractor shall be liable to the City for any loose or damage to the motorized cart, normal wear and tear excepted, that is caused by the guard to whom it has been assigned. Two call boxes are also located at this facility to facility emergency contact by customers or the contractor with the City's independently contracted alarm service, if such services are not provided by the contractor.

At the New River Marginal Docks and Las Olas Marina and Anchorage, the City shall make available daily, one City Police Radio to expedite emergency calls for Police response. The Security Officer is required to pick up the radio from the Fort Lauderdale Police Department at shift commencement and return the radio at shift completion daily. No exception to this requirement may be made. The guard shall return the radio at the end of each shift in the same condition as it was distributed to them, and the contractor shall be liable to the City for any loose or damage to the radio, normal wear and tear excepted, that is caused by the guard to whom it has been assigned.

05. SERVICES AND EQUIPMENT PROVIDED BY CONTRACTOR

- A). Contractor to provide the officer, the vehicle, uniform for the officer, communications equipment for the officer, supervision of the officer and twenty four (24) hour per day, seven days per week communications access for the City and officer.
- B). Contractor shall have a regular business office located in the tri-county area (Dade, Broward, Palm Beach). The Contractor's dispatch facility shall be staffed by full-time employees of the contractor at a location properly zoned for such activity.
- C). Except where provided by the City for roving services, the Security Officer must have communications equipment that will allow him to contact his office, the Supervisor of Marine Facilities or designee and the Fort Lauderdale Police Department (ie. radio, cellular phone, etc). The Security Officer will carry a flashlight with batteries. The vehicle must be equipped with a life buoy ring secured by a rope in the event to aide assisting any person that may be observed

05. SERVICES AND EQUIPMENT PROVIDED BY CONTRACTOR(Cont.)

- c). having fallen in the water. The vehicle may be equipped with a bicycle to aide in patrolling some slips that may not be readily observed from the street, and the Contractor in submitting its proposal shall identify whether or not it feels that equipment is necessary and whether it will be provided with the vehicle.
- D) Except where the City requires or has requested a Level C Armed Security Officer, no other officer providing services—shall carry arms, even if properly trained and licensed. Arms shall include, but are not limited to; weapons, mace/pepper spray and nightstick.
- E). The Security Officer will be neatly groomed, in the approved uniform and properly equipped.
- F). The security vehicle shall be clean and properly maintained.
- G). A backup vehicle must be available within 30 minutes and have the equipment and capabilities of vehicle requirements indicated in these specifications.
- H). Both the Security Officers uniform and vehicle shall be clearly identified with the security firms name and be identified with the City's logo or other identification to notify the public that the Security Officer is providing the service for the City. The Officer shall wear a nametag and the vehicle shall have the telephone number of the security firm prominently displayed.
- 1). The Security Officer will report to the designated initial location on time and will remain on duty until the end of the shift or until properly relieved. No officer will work more than a twelve (12) hour shift in a twenty four (24) hour period.
- J). The Security Officer will maintain a good personal and uniform appearance, be courteous to residents and visitors at the facilities and to City personnel. The Security Officer will not conduct any personal activity that would detract from a professional image.
- K). The Security Officer will patrol the facilities both in the vehicle and on foot to inspect all parts of the facilities for the purpose of detecting and preventing individuals or groups from committing acts that are illegal or injurious to others or to the property. The Security Officer shall complete a "Incidence Report" to be provided to the Supervisor of Marine Facilities or his designee at the completion of the shift for any contact initiated by the Security Officer against unauthorized parties or involving customers who may be reporting violations or suspicious activities or who's conduct on City property may voluntarily or involuntarily warrant response from the Security Officer. The Incidence Report shall also be completed even when reported activity involves response by Fort Lauderdale Police to further document the circumstances and confirm that a Police Report is in the process of being made.

05. SERVICES AND EQUIPMENT PROVIDED BY CONTRACTOR(Cont.)

- L). The Security Officer will contact the appropriate party when such events occur or have occurred. The Supervisor of Marine Facilities or his designee should be contacted in routine or non-emergency cases. The Fort Lauderdale Police Department and the Officers Supervisor must be immediately contacted in emergency situations or when assistance is thought to be needed. It is not expected that the Security Officer will enter into a direct confrontation with persons at the facilities.
- M). The Security Officer will report safety hazards, malfunctioning equipment and other such matters to the Supervisor of Marine Facilities or his designee. Personnel from the Marine Facilities Section will be available to respond to such reports 24 hours per day, seven days per week.
- N). The Security Officer will maintain a daily logbook, recording all instances that may be of interest to Supervisors or City personnel.
- O). The Security Officer will inspect each slip at the facilities in order to compare and document the status of the occupancy of the slip against the "Slip Inventory Report" provided at the close of business for that day. Each slip shall be inspected no less than once during the shift and more frequently depending on the location the minimum frequency of coverage required. Unregistered vessels shall be documented and reported on the forms provided, and in accord with the more detailed written instructions that will be provided to the successful contractor prior to commencement of services.
- P). A Security Firm Supervisor will visit the Security Officer at least once during each shift to insure that the Security Officer is following proscribed procedures. Such visits are to be entered in the log. The Security Firm Supervisor shall visit all of the facilities at least once each week to familiarize himself with their condition and any possible safety or security problems or potential problems. The supervisor, or other qualified personnel approved by the City shall take over for the Security Officer during any meal or other breaks when the Officer is not on his route and observing the site.

06. OTHER EQUIPMENT

A). The City is also considering the use of electronic time keeping devices or wands, and touch button and/or bar code readers to be placed in the vicinity of each slip. These will serve as checkpoint stations. Daily data will be downloadable to a City computer. The Security Officers will be required to complete rounds utilizing such devices and returning the device to its designated docking station at the end of each shift. City Marine Facility personnel will review daily the prior days data. These systems shall be purchased and owned by the City. They would be distributed to the security guards at the beginning of each shift. The guard shall return them at the end of each shift in the same condition as it was distributed to them, and the contractor shall be liable to the City for any lose or damage to the device, normal wear and tear excepted, that is caused by the guard to whom it has been assigned. Examples of the products currently under consideration are provided as referenced below.

06. OTHER EQUIPMENT (Cont.)

- B). As identified in Part IV, Paragraph 4 above, the City maintains two security call boxes on-site at the Cooley's Landing Marina. Each call box is equipped with a 800 Mhz radio activated system that is compatible to City Police and Park Ranger radio equipment. The proposer shall include in its pricing proposal optional information on whether the security company maintains a 24-hour 800 Mhz dispatch allowing it to provide call box monitoring services, and it's price per box per month to provide this service if requested by the City.
- O7. MARINE FACILITIES SECURITY ZONES AND FREQUENCY OF SERVICE
 The Marine Facilities Section currently defines the operational areas to receive security services under this contract in eight zones as listed in the chart below. 07. MARINE FACILITIES SECURITY ZONES AND FREQUENCY OF SERVICE (Cont.)

The frequency of services provided at Zone 1 shall be continuous for the level of service currently required in accord with the initial scope of services. The Security Officer regularly inspects each slip at the facility by visible observation from the cart or on foot.

Barring an incident requiring deviation or variation from the routine route, the frequency of service provided at Zones 2 and 3 shall be one time during the shift while the frequency of service provided at Zones 4, 5 and 6 shall be at least two times and more preferably three times during the shift. The frequency of services provided at Zone 7 and 8 shall be one time during the shift between the hours of 12 AM to 2 PM unless otherwise instructed in writing by the Supervisor of Marine Facilities.

The roving Security Officer inspects the slips at each zone by visible observation from the vehicle or on foot or bicycle. The roving Security Officer shall utilize the parking area available on the west end of the Las Olas Bridge to get out of the car and make a visible inspection of boats moored at the Las Olas Anchorage before proceeding to conduct rounds at the Las Olas Marina.

The Contractor shall consider the established zones and routes and, in completing its Technical Proposal, shall provide in its narrative descriptions what assurances and controls it will have in place on assigned Security Officers to assure a dedicated and continuous work effort is employed at all facilities receiving services, and provide its estimate of the number of times Zones 4, 5 and 6 shall be inspected through the level of service currently required in accord with the initial scope of services.

08. POST OPERATING ORDERS
