A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA AUTHORIZING AND APPROVING THE MAYOR AND TOWN OFFICIALS TO EXECUTE A CONTRACT RENEWAL FOR A ONE YEAR EXTENSION WITH THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION PERTAINING TO A HIGHWAY LANDSCAPE MAINTENANCE AGREEMENT PREVIOUSLY AUTHORIZED UNDER RESOLUTION 1168.99; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Golden Beach approved Resolution 1168.99 on the 18th day of May, 1999 authorizing Town Officials to enter into a Highway Landscape Maintenance Agreement with the State of Florida Department of Transportation; and

WHEREAS, the Town of Golden Beach entered into a Highway Landscape Maintenance Agreement with the State of Florida Department of Transportation on the 16th day of August, 1999 for a five year term; and

WHEREAS, the Agreement provides renewal on a yearly basis for a maximum of two years; and,

WHEREAS, the State of Florida Department of Transportation desires to extend the contract for an additional year;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. That the Town Council hereby approves the Contract Renewal between the Town of Golden Beach and the Florida Department of Transportation Turf and Landscape Maintenance Memorandum of Agreement, a copy of which is attached as Exhibit "A".

- <u>Section 2.</u> That the Mayor and appropriate Town Officials are hereby authorized to enter into a one year extension of the Department of Transportation Turf and Landscape Maintenance Memorandum of Agreement with the Town of Golden Beach.
- Section 3. Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
- <u>Section 4. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
- <u>Section 5.</u> Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council.
