## **RESOLUTION NO.** <u>1708.05</u>

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, ACTING IN ITS CAPACITY AS THE DESIGNATED LOCAL PLANNING AGENCY OF TOWN OF GOLDEN BEACH, FLORDA. THE RECOMMENDING APPROVAL OF THE PROPOSED EVALUATION AND APPRAISAL REPORT FOR THE TOWN GOLDEN BEACH COMPREHENSIVE PLAN; AUTHORIZING THE TOWN'S CONSULTANT PLANNER TO TRANSMIT THE DRAFT REPORT TO THE DEPARTMENT OF COMMUNITY AFFAIRS AND OTHER REQUIRED REVIEW AGENCIES FOR COMMENT PRIOR ADOPTION; AUTHORIZING THE TRANSMITTAL OF THE DRAFT REPORT TO THE TOWN COUNCIL AS PART OF THE COMPREHENSIVE PLAN PROCESS IN ACCORDANCE WITH SECTION 163.3191, FLORIDA STATUTES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVDING AN EFFECTIVE DATE.

WHEREAS, the Town of Golden Beach is a municipality located in Miami-Dade County, Florida; and

WHEREAS, the Florida Legislature intends that local planning be a continuous and ongoing process; and

WHEREAS, the Town Council adopted the current Town of Golden Beach Comprehensive Plan by Ordinance No. 368-88 on December 6<sup>th</sup>, 1988; and

WHEREAS, Section 163.3191, Florida Statutes, directs local governments to periodically assess the success or failure of the adopted plan to adequately address changing conditions and state policies and rules, study issues and update data; and

WHEREAS, Section 163.3191, Florida Statutes, directs local governments to adopt needed amendments to ensure that the plan provides appropriate policy guidance for growth and development; and

WHEREAS, the Town's Comprehensive Planning Board (An Advisory Board but not the designated Local Planning Agency) has reviewed the Evaluation and Appraisal Report, provided for participation by the public in the process, and rendered its recommendations to the Local Planning Agency; and WHEREAS, the Town Council, acting as the designated Local Planning Agency (LPA), has reviewed the Evaluation and Appraisal Report prepared by Michael Miller Planning Associates, Inc., the Town's Consulting Planner, held an advertised public hearing, provided for participation by the public in the process, and rendered its recommendations to the Town Council; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA SITTING AS THE LOCAL PLANNING AGENCY FOR THE TOWN OF GOLDEN BEACH, AS FOLLOWS:

<u>SECTION 1</u>. The Local Planning Agency provided for and heard comments at a duly noticed public meeting on the proposed Evaluation and Appraisal Report and has recommended approval and transmittal of same to the Town Council of Golden Beach and to the Department of Community Affairs and other required review agencies.

SECTION 2. The Local Planning Agency hereby authorizes the Town Clerk and Michael Miller Planning Associates, Inc., as the Consultant Town Planner, to transmit the proposed Evaluation and Appraisal Report and other supporting documentation to the Florida Department of Community Affairs and other required review agencies for the purpose of an early sufficiency review in accordance with Section 163.3191, Florida Statues. The Town understands that the Evaluation and Appraisal Report is subject to further revision based upon comments from the Department of Community Affairs and other required review agencies. The Local Planning Agency hereby authorizes the transmittal of the final draft Evaluation and Appraisal Report to the Town Council for adoption.

SECTION 4. Severability. That a decision by a court of competent jurisdiction declaring invalid any section, paragraph, sentence, clause, phrase or other part of this Resolution shall not affect the validity of this Resolution as a whole or any parts thereof, other than the part so declared to be invalid.

<u>SECTION 5. Conflict.</u> That all Sections or parts of Sections of the Code of Ordinances, all Ordinances or parts of Ordinances, and all Resolutions, or parts of Resolutions, in conflict are hereby repealed to the extent of such conflict.

SECTION 6. Effective Date. This Resolution shall become effective immediately upon its adoption.
