A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA APPOINTING WEISS, SEROTA, HELFMAN ET. AL., AS TOWN ATTORNEY; PROVIDING FOR EXECUTION OF AN ATTORNEY FEE AGREEMENT; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the current Town Attorney for the Town of Golden Beach submitted his resignation under the terms of the Agreement between the Town and the Town Attorney; and

WHEREAS, the Town of Golden Beach seeks to appoint Weiss, Serota, Helfman, et. al., as Town Attorney on the terms and conditions contained in the attached Attorney Fee Agreement;

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

- Section 1. That Weiss, Serota, Helfman, et. al. be, and he/it is hereby appointed as Town Attorney for the Town of Golden Beach effective May 18, 2005.
- Section 2. Weiss, Serota, Helfman, et. al., shall be compensated and shall be employed in accordance with the Attorney Fee Agreement, a copy of which is attached hereto and incorporated herein as Exhibit "A". The Mayor be, and he is hereby authorized to execute said Agreement on behalf of the Town.
- <u>Section 3.</u> Severability. That the provisions of this Resolution are declared to be severable and if any section, sentence, clause or phrase of this Resolution shall, for any reason, be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, clauses, sentences and phrases of this Resolution but they shall remain in effect, notwithstanding the invalidity of any part.
- <u>Section 4. Conflict.</u> That all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.
- Section 5. Effective Date. That this Resolution shall become effective immediately upon approval of the Town Council

SUBJECT: Appointment of Town Attorney

### **BACKGROUND/HISTORY:**

The Mayor requested that I update you on the search for a new law firm following the resignation tendered by Mr. Eichner on April 19<sup>th</sup>, 2005. Mayor Singer and I reviewed the resumes forwarded to the Town Clerk and we interviewed the following firms:

The Mayor determined that it was more cost efficient to go with a larger firm that can be utilized to do the entire Town's work as opposed to contracting out different matters. The firm he has selected has this capability and in addition pointed out that they do not bill for phone conversation with staff. A review of past billings showed that this will result in a considerable savings for the Town.

Based on those interviews The Mayor is recommending the firm Weiss Serota Helfman with Attorney Stephen Helfman being the Town's contact attorney.

### Re: Engagement of Weiss Serota Helfman Pastoriza Cole & Boniske, P.A.

Dear Mayor Singer and Councilmembers:

We are pleased that you wish to engage our Firm to serve as Town Attorney for the Town of Golden Beach. From our experience, we have found that clients appreciate a frank and open discussion and understanding of the services that we will perform and the basis upon which they will be expected to pay for those services.

This letter is intended to set forth our understanding as to the nature and scope of the legal services we have agreed to render for you, the amount of our fees for those services, the manner in which our fees will be paid.

1. Nature of Legal Services. You have engaged us to serve as Town Attorney for the Town of Golden Beach. In that capacity, we will act as your general counsel responsible for all of the Town's legal matters. Our services include, but are not limited to, attending all meetings of the Town Council and boards as required by your Charter, preparing all resolutions, ordinances, contracts and other agreements, instituting or defending litigation, as well as providing day-to-day

advice to the administration and councilmembers on matters such as planning, zoning, public records and sunshine law.

2. Fees for Services. With the exception of the telephone calls described below, you will be charged and agree to pay for our services at the rate of \$200 per hour for all attorneys, together with applicable taxes, if any. This hourly rate shall increase 5% annually on the armiversary date of this agreement. It is our practice to charge for actual time expended on your behalf, but not less than 2/10ths of an hour for each activity. In the event that two attorneys attend a Council meeting for our convenience, the Town would not be billed for their attendance. If, of course, the attendance of two attorneys is required, for example, on a litigation or quasi-judicial land use matter, both attorneys time will be billed.

We believe strongly that close communication between the Town and the Firm is essential to minimizing legal problems and expenses and would not want the Mayor, Councilmembers or the Town Manager to ever feel constrained or hesitant to call us for advice. We would therefore not charge for any telephone conferences with these individuals.

- 3. Costs. In addition to the fees discussed in paragraph 2, we anticipate that certain expenses may be incurred and advanced on your behalf. These expenses may include filing fees, recording costs, out-of-town travel expenses, delivery charges, long distance telephone charges, photocopies (xerox), special postage (express mail, certified mail and the like), computer research charges, court reporter expenses (including cost of transcript and court reporter's fee for attendance), and court costs (such as filing fees, service of process, newspaper publication costs, subpoena costs, witness fees, recording fees, etc.). In addition to our fees for legal services, you agree to pay us for such out-of-pocket expenditures.
- 4. Payment of Fees and Costs. Our invoices will be submitted to you on a monthly basis and each invoice will be due and payable when rendered. If any invoice remains unpaid for more than 30 days after it is rendered, we reserve the right, in our discretion, to cease to provide further legal services to you. You will, however, be liable to us for the payment of any fees earned and any costs incurred by us to that time.
- 5. <u>Termination of Representation</u>. We will serve at the pleasure of the Town Council and may be terminated at any time.
- 6. <u>Commencement of Representation</u>. If the foregoing is agreeable to you, please acknowledge your understanding and agreement by signing this letter and delivering it to us.
