

**RESOLUTION NO. 1725.05**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING AND APPROVING THE ATTACHED MUTUAL AID AGREEMENT AND JOINT DECLARATION BETWEEN THE TOWN OF GOLDEN BEACH AND THE CITY OF SUNNY ISLES BEACH, FLORIDA; AUTHORIZING TOWN MAYOR AND POLICE CHIEF TO EXECUTE THE AGREEMENT AND JOINT DECLARATION; AUTHORIZING IMPLEMENTATION OF THE AGREEMENT AND JOINT DECLARATION; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, there exists a continuing possibility of public safety concerns including law enforcement problems and other natural and manmade conditions which are, or are likely to be, beyond the control of the services, personnel, equipment or facilities of the Town of Golden Beach Police Department and the City of Sunny Isles Beach Police Department; and

**WHEREAS**, pursuant to the Florida Mutual Aid Act, Chapter 23, Florida Statutes, municipalities have authority to enter into mutual aid agreements to permit voluntary cooperation and assistance of a routine law enforcement nature across jurisdictional lines; and

**WHEREAS**, the Town of Golden Beach (the "Town") and the City of Sunny Isles Beach (the "City") desire to enter into a Mutual Aid Agreement and Joint Declaration for these purposes; and

**WHEREAS**, the Town Council finds that approval of the Mutual Aid Agreement and Joint Declaration between the Town and the City is in the best interest of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:**

**Section 1.      Recitals Adopted.** That each of the recitals stated above is hereby adopted

and confirmed.

**Section 2. Agreement Approved.** That the Mutual Aid Agreement and Joint Declaration, in substantially the form attached hereto, are hereby approved, and the Town Mayor and Police Chief are hereby authorized to execute said Agreement and Joint Declaration, on behalf of the Town, once approved as to form and legal sufficiency by the Town Attorney.

**Section 3. Implementation.** That the Town Mayor and Town Manager are hereby authorized to take any and all action necessary to implement the terms and conditions of the attached Agreement and Joint Declaration.


**Section 4. Effective Date.** That this Resolution shall take effect immediately upon adoption hereof.


The Motion to adopt the foregoing Resolution was offered by Mayor Singer, seconded by Vice Mayor Lusskin and on roll call the following vote ensued:


