## RESOLUTION NO. 1728.05

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AUTHORIZING THE TOWN MANAGER TO TRANSFER A TOTAL OF SEVEN THOUSAND FOUR HUNDRED SEVENTY SEVEN DOLLARS (\$7,477.00) FROM THE PUBLIC WORKS AND MAINTENANCE DEPARTMENT LANDSCAPING ACCOUNT (ACCOUNT NO.: 001-539-467000-00-000) TO THE GENERAL GOVERNMENT PROFESSIONAL SERVICES EXTERMINATOR ACCOUNT (ACCOUNT NO.: 001-519-341000-00-000) FOR MOSQUITO CONTROL EXPENSES NOT INCLUDED IN THE 2004-2005 BUDGET; PROVIDING **PROVIDING** FOR IMPLEMENTATION: EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Golden Beach, Florida (the "Town") adopted a General Fund Budget for the 2004-2005 Fiscal Year and the need exists to transfer funds to accommodate mosquito control expenses which were not included in the adopted Budget; and

WHEREAS, the Town Council finds that the transfer of funds from the Public Works

Department Landscaping and Maintenance Account to the General Government Professional

Services Exterminator Account for these purposes is in the best interest of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That each of the above-stated recitals is hereby adopted and confirmed.

Section 2. Authorization. That the Town Manager is hereby authorized to amend the 2004-2005 Budget by transferring Seven Thousand Four Hundred Seventy Seven Dollars (\$7,477.00) from the Public Works Department Landscaping and Maintenance Account (Account No.: 001-539-467000-00-000) to the General Government Professional Services Exterminator

Account (Account No.: 001-519-341000-00-000) for mosquito control expenses.

**Section 3.** Implementation. That the Mayor and Town Manager are authorized to take any and all action which is necessary to implement this Resolution.

Section 4. Effective Date. That this Resolution shall be effective immediately upon adoption.
