## **RESOLUTION NO. 1742.05**

A RESOLUTION OF THE TOWN OF GOLDEN BEACH, AWARDING PAVER REPLACEMENT FLORIDA. PROJECT (BID NO. 2005-03) (THE "PROJECT") TO PIOS INC.; SONS ENTERPRISES, APPROVING AGREEMENT FOR CONSTRUCTION OF THE PROJECT BETWEEN THE TOWN AND **PIOS** & SONS INC.; **PROVIDING** FOR ENTERPRISES. IMPLEMENTATION OF AGREEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to an advertised solicitation requesting proposals for providing pavers, stamped concrete, or stamped asphalt for various locations within the Town of Golden Beach (the "Project"), the Town received a sealed proposal from a qualified contractor, Pios & Soas Enterprises, Inc., ("Pios") for the construction of the Project; and

WHEREAS, the Town Council finds that it is in the best interest of the Town to award the Project to Pios as the lowest responsible bidder in accordance with the applicable codes and ordinances of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

- Section 1. Recitals Adopted. Each of the above recitals are hereby adopted, confirmed and incorporated herein.
- Section 2. Project Awarded. That the Project, as described in the attached Contract (the "Agreement"), is hereby awarded to Pios, for a contract price which shall not exceed \$123,506.20.
- Section 3. Agreement Approved. That the Agreement, in substantially the form attached hereto, between the Town and Pios is hereby approved, and the Mayor is hereby Resolution No. 1742.05

authorized to execute the Agreement, on behalf of the Town, once approved as to form and legal sufficiency by the Town Attorney.

Section 4. Implementation. The Mayor and Town Manager are hereby authorized to take any and all action necessary to implement this Resolution in accordance with its terms and conditions.

Effective Date. This Resolution shall be effective immediately upon Section 5. adoption.
