A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, APPROVING A VARIANCE REQUEST FOR THE PROPERTY LOCATED AT 674 OCEAN BOULEVARD, GOLDEN BEACH, FLORIDA 33160 TO ALLOW A SECOND TO FIRST FLOOR AREA RATIO OF 67.8%; PROVIDING FOR CONDITIONS; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the applicant, Reuben Ezekiel (the "Applicant"), filed a Petition for Variance from Section 66-69(3) of the Town Code to permit a second to first floor area ratio of 67.8% in lieu of the 65% second to first floor area ratio requirement for the property located 674 Ocean Boulevard, Golden Beach, Florida 33160 (Golden Beach Section "A", Lot 16 & N ½ of Lot 15, Block 1, as recorded in PB 9-52, of the Public Records of Miami-Dade County, Folio No. 19-1235-001-0160) (the "Property"); and

WHEREAS, a public hearing of the Town's Building Regulation Advisory Board was advertised and held, as required by law, and all interested parties were given an opportunity to be heard; and

WHEREAS, a public hearing of the Town Council was advertised and held, as required by law, and all interested parties were given an opportunity to be heard; and

WHEREAS, the Town Council having considered the evidence presented, finds that the Petition for Variance meets the criteria of the applicable codes and ordinances to the extent the application is granted herein.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF GOLDEN BEACH, FLORIDA, AS FOLLOWS:

Recitals Adopted. That each of the above-stated recitals is hereby adopted

Section 2. Approval. The Petition for Variance is hereby granted.

Section 3. Conditions. The Petition for Variance as granted, is subject to the following conditions:

- (1) Applicant shall record a certified copy of this Resolution in the public records of Miami-Dade County; and
- (2) Construction shall be completed substantially in accordance with those certain plans entitled <u>Interior Renovation Reuben Ezekiel Residence</u>, as prepared by Joseph B. Kaller & <u>Associates</u>, P.A., dated <u>11/6/05</u>, and containing pages <u>SP-1</u>, <u>A1-A4</u>.
- (3) A Building Permit for the contemplated work pursuant to the Petition for Variance must be obtained within one (1) year from the date of this Resolution. If no Building Permit is issued within the one (1) year time limit, then the Variance approval shall be null and void.

Section 4. Implementation. That the Building and Zoning Director is hereby directed to make the necessary notations upon the maps and records of the Town of Golden Beach Building and Zoning Department and to issue all permits in accordance with the terms and conditions of this Resolution. A copy of this Resolution shall be attached to the building permit application documents.

Section 5. Effective Date. That this Resolution shall be effective immediately upon adoption.
